

Temple University has been shaping the future and making a positive difference in people's lives since 1884. Dr Russell H. Conwell started Temple with just seven students. Now, more than 100 years later, the University is one of the nation's senior comprehensive research institutions, with specialized programs all over the world.

Dr Conwell, the founder and first President of Temple University, believed that great opportunities can be found close to home if one is willing to invest the time and effort to discover them. His philosophy was immoratalized in his now-famous "Acres of Diamonds" speech, based on the story of a Persian farmer who deserted his homeland in search of wealth in mythical diamond fields. After spending years in a worldwide search, he died an unhappy pauper, no closer to discovering the diamonds than when he began. Soon afterward, fabulous diamonds, acres of then were found on his own land.

For Dr. Conwell, the story had great significance. It said, "Your diamonds are not in far distant mountains or in yonder seas; they are in your own backyard, if you but dig for them."

Using their undergraduate education and training, Temple alumni have helped shape the fields of government, business, industry, the performing and communications arts, science, research, law, medicine and technology.

KDR Temple University is proud to have Dr. Robert Solomon Ph.D. as our faculty advisor. Dr. Solomon has national recognition in the field of physics. He is one of our sources of pride and motivation. We greatly acknowledge his contributions.

Temple undergraduates are as diverse as the course offerings available. They come from private, parochial, public and preparatory schools, from almost every state in the union, and from many foreign countries. They range in age from 16 to 60. Some are just beginning their college education. Others are transfer students from other postsecondary indstitutions. Still others are adults, seeking to expand their knowledge, meet new challenges, or change careers.

#### Brief History Kappa Delta Rho Fraternity Provisional Chapter Temple University

In the fall of 1982 at the recomendation of Scott Lehman, Consul of Mu Alpha chapter, West Virgina University. the National office of Kappa Delta Rho contacted his home town friend Gregory Ondick, concerning his interests in establishing KDR at Temple University. After a great amount of effort Greg and the first members were successful in increasing the membership and obtaining all the necesarry approvals.

Friday April 15, 1983 KDR Rho chapter Laffayette Colleges' representatives: Dan Sammartino, Consul, Oliver Mueller, Charles Gatt and Dennis Walsh performed the provisional chapter cermonies fo XI Alpha. Representative Donald Stohl Zeta '53 and Richard W. Nolan Theta '59 were the National representatives. The sponsoring Rho chapters representatives formally pledged the members and the provisional chapter of Kappa Delta Rho Inc. was formally established at Temple University.

The new provisional chapter hosted a social in honor of the ocasion. The next day several of the Temple members drove to New Brunswick to attend the Rutgers Colony installation.

#### PROVISIONAL CHAPTER OF KAPPA DELTA RHO, INC.

#### AT TEMPLE UNIVERSITY

#### ARTICLE I: NAME

The name of this Fraternity shall be Temple University Provisional Chapter of Kappa Delta Rho, Incorporated.

#### ARTICLE II: PURPOSES

The primary purpose of the Fraternity shall be the promotion of good fellowship amoung its members and the advancement of truth, justice, and virtue.

The Fraternity shall provide a source of identity and, if responsibly led, a source of dignity for every member. The Fraternity will be a significant force in preparing its members for the challenges of the complex life they must face. The fraternity clearly recognizes the need for scholastic achievement, intellectual honesty, community service, and personal group fiscal responsibility.

The provisional Chapter of Kappa Delta Rho, Inc. at Temple University accepts the opportunity of contributing to the general education of its members.

#### ARTICLE 111: MEMBERSHIP

- Section 1. The membership of this Fraternity shall consist of honorary members, alumni, actives, and pledges.
- Section 2. Honorary members shall consist of outstanding faculty members or other men of good repute elected by the active chapter, and approved by the National.
- Section 3. Alumni shall consist of those actives of the Fraternity who shall have completed their work at Temple University or those actives, due to personal reasons, terminated their college career proir to graduation.
- Section 4. Actives shall consist of undergraduates, fully initiated upon completion of all requirements set by the Fraternity and University.
- Section 5. Pledges: Prospective members awaiting completion of the requirements for initiation.

Section 6. Pledges will become active members after receiving a 4/5 vote through secret balloting at an authorized meeting of active members.

#### ARTICLE IV: OFFICERS

- Section 1. President: The presiding officer of the Chapter. He presides at all meetings, enforces the laws, and serves on the capacity of general administrator. He makes all appointments to all committees with the approval of the Executive Committee.
- Section 2. First Vice President: Is the Rush Chairman and presides the duties of President in his absence or incapacity. He will fill the position of President should the current President not be able to complete his elected term.
- Section 3. Second Vice President: Has full responibility for all pledges and directs the pledge training program. He supervises the testing of pledges on the material required. He serves in the capacity of First Vice President in his absence.
- Section 4. Secretary: The recording secretary of the Fraternity. He conducts all correspondence and keeps the minutes of all meetings in a permanent form. He maintains all intiation forms and the Bylaws.
- Section 5. Treasurer: The treasurer of the Fraternity. He collects all fees and pays all bills, keeping accurate records of all money received and disbursed. He shall be responsible for preparing a budget for the forthcoming year subject to the approval of the Executive Committee.
- Section 6. Sergeant-at-Arms: The doorkeeper of the Fraternity meetings. He receives the handclasp of all initiates before their admission to Fraternity meetings. He maintains all ritual equipment and maintenance of the meeting room.
- Section 7. Chaplain: Chaplain of the Fraternity. He has charge of all devotional exercises in which the Fraternity participates. He is responsible for the invocation before all Fraternity meetings.
- Section 8. Housemanager: Will be responsible for the care, upkeep, and cleanliness of the Chapter House.
- Section 9. I.F.C. Representatives: They are the official representatives of the Fraternity at all Interfraternity Council meetings.
- Section 10. Executive Committee: Shall consist of President, First Vice President, Second Vice President, Secretary, and

Treasurer. The committee prepares the agenda for all meetings and deals with all special problems as they arise. The Executive Committee will also assist the President in his appointments of the Social Chairman, Social Service Chairman, Intramural chairman, Scholarship Chairman, and their committee members. They shall appoint other committees as the needs arise.

#### ARTICLE V: ELECTIONS

Elections will be conducted the first or second week of the spring semester or second quarter as the case may be. Nominations will be made during the Fraternity meeting prior to the election. All nominations for all elected positions will remain open until the elections. All members nominated must be in good financial standing with the Fraternity. Upon completion of the elections, the President and Executive committee shall meet to make appointments.

#### ARTICLE V1: MEMBERSHIP REQUIREMENTS

Section 1. Pledges: To become a pledge, each upperclassman to be considered must have a "C" average. Freshman requirements will follow those set by the school requirements. All rushees must also upon a vote of the actives of the Fraternity receinve no more than "three" negative votes. Although a rushee did not receive a bid as a result of the first voting, the Rushing chairman may present his name before the actives for another vote. Should the rushee again not receive a favorable vote, his name will be retired from the Fraternity's list of rushess.

Section 2. Actives: To become initiated as a full member of the Fraternity, each pledge must complete all requirements set by the National Fraternity, and receive no more than "three" negative votes from the active membership prior to the initiation.

#### ARTICLE VII: FINANCES

Section 1. All financial requirements set by the Fraternity upon its membership shall be purposed by the Executive Committee and aproved by the active membership by a 3/4 vote.

Section 2. Semester dues shall be as followed:

A. Seventy five (\$75.00) dollars for all Brothers living in

the house.

B. Eighty five (\$85.00) dollars for all Brothers

outside the house. The extra ten (\$10.00) dollars will

be appropriated for house maintenance.

Section 3. Their will be a forty five (\$45.00) dollar pledge fee and an initiation fee of one hundred and five (\$105.00) dollars.

Section 4. All payments must be made within two weeks of the due date or members will be placed on probation.

#### ARTICLE VIII: MEETINGS

- Section 1. The regular meetings of the active Fraternity shall be held every Monday beginning at 9:00 p.m.. Special meetings may be called at any time by the President subject to the approval of the Executive Committee.
- Section 2. At all regular meetings a majority will be required to conduct any business.
- Section 3. Permission may be given by the President to any active member to be absent from a meeting providing it is a legitimate excuse given to the President at least twenty-four hours before the meeting.
- Section 4. Any memger being absent from a meeting without permission shall be fined five (\$5.00) dollars.
- Section 5. Any member arriving up to fifteen minutes after the start of the meeting will be fined \$2.50. Any member arriving after fifteen minutes will be fined the amount of the absent fee of \$5.00.
- Section 6. The secretary will call role upon the President opening the meeting.
- Section 7. Any member missing three consecutive unexcused authourized meetings will be placed on probation.

#### ARTICLE IX: RUSHING

- Section 1. Due to the importance of all rushing functions, all members will be required to attend. All members meainig active and pledges. Those not present will be fined five (\$5.00) dollars.
- Section 2. Pledge training period shall be eight weeks long and will take place during each semester.
- Section 3. Every pledge will be assigned a "Big Brother" who will offer his guidance during the pledge period.

#### ARTICLE X:PROBATION

Members on probation will be called upon the Executive Committee to review the members records.

#### ARTICLE XI: AMENDMENTS

These Bylaws may be amended by a three-fourths vote of the active members present at an authouized meeting. The purpose of the propoosed amendment having been presented one meeting prior to its call for approval.


### SPRING FLING
