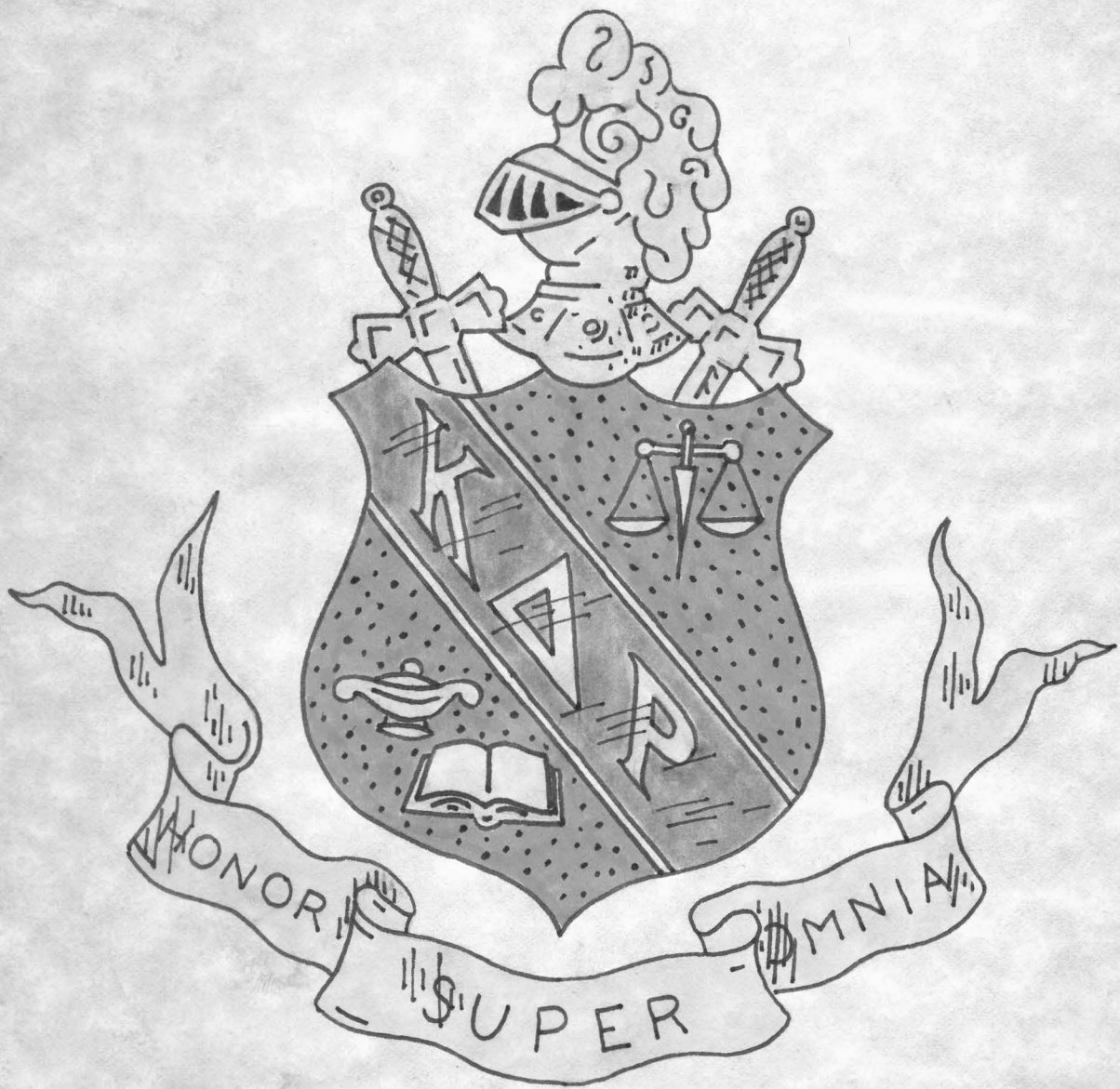

A BRIEF HISTORY OF  
THE UNIVERSITY OF PITTSBURGH AT GREENSBURG

The University of Pittsburgh at Greensburg is one of four regional campuses of the mother campus located in Oakland. The Greensburg campus first began in September of 1963 utilizing rental space to hold classes on Maple Avenue in downtown Greensburg. The regional campus was established at this time so that the the University might accomplish its objective of serving the educational needs of western Pennsylvania and the upper Ohio Valley and to provide a small college atmosphere within a large university system.

Presently the Greensburg campus is located on the 160-acre site of the estate of the late Charles McKenna Lynch, just 33 miles east of the main campus. After acquiring the mansion and establishing administrative offices there, the campus has since grown from its humble start on Maple Avenue. Powers Hall, a multi-purpose structure completed in 1974, houses the library collection and provides classroom space. Completed at the beginning of 1976 was the Albert B. Smith Science Building which includes an auditorium-style classroom, natural science and engineering labs, a computer science center, the campus bookstore, classrooms and offices. Also completed early in 1976 was the Student Activity Center; it provides fast-food service, a lounge, a newly added larger game room, and the Student Government Association Office. The campus has just begun the first phase of a five-year growth and expansion plan and as of this writing a new faculty office building is being constructed, a new telephone system is being implemented to facilitate the beginning of The Campus of The Future system developed by AT&T. Also two new dormitory buildings, maintenance building, a Common Facilities Building that will contain a gymnasium as well as many other much needed facilities is in the design phase.

Within the past six years, the enrollment of the Greensburg campus has grown by 40 percent. Currently there are over 800 full-time and 700 part-time students.



HISTORY OF KAPPA DELTA RHO  
AT THE UNIVERSITY OF PITTSBURGH AT GREENSBURG

The formation of Kappa Delta Rho at the University of Pittsburgh at Greensburg began through humble circumstances. A handful of aspiring young men, through hard work and determination made the necessary connections to start the ball rolling. Much of the credit for the early formation must go to Robert McCloskey, U.P.G.'s first Kappa Delta Rho President, through tireless effort and dedication, helped launch KDR at U.P.G.

The early meeting of the prospective members were held in the cramped living quarters of four future members apartment: C-5 at University Court. It was here that hours of sometime chaotic discussion occurred among the future brothers.

Finally, through hard work, and maybe a bit of prayer, Kappa Delta Rho granted U.P.G. a provisional chapter. On October 17, 1985 twenty-five young men were initiated by the National Order at Our Lady Of Grace Church in Greensburg. Following the ceremony a celebration was held at Fort Allen Firehall.

The winter term of 1986 was a busy time for the new provisional chapter. Jeff Schaefer was elected President. An intensive rush program helped attract ten more fine pledges.

In April of '86, Kappa Delta Rho at U.P.G. conducted one of its most successful philanthropic projects to date. Brothers raised a substantial amount of money by "stuffing" 25 people into a telephone booth for a prospective transplant patient.

During the fall term of 1986, the brothers held two more important philanthropic events. A "Pajamarama" was held with the proceeds going to the American Heart Association. Several brothers also raised money through carolling for "Operation Santa Claus." A fundraiser sponsored by a local newspaper to provide needy families with a Christmas meal.

Elections were held in November of 1986. Donald Ravasio was elected to succeed Joseph Bilik as President. Other newly elected officers are as follows: Scott Dallas, First Vice-President; Wayne Lewandowski, Second Vice-President; Shawn Nedley, Treasurer; and Ronald DeGuffroy, Secretary.

The winter term of '87 got off to a fast start for the brothers at U.P.G. A new pledge class began its training during the second week of school. After enduring an intensive pledge program, five more men became brothers. Currently another pledge class is undergoing the pledge program.

PROVISIONAL CHAPTER BYLAWS  
as of 1-12-87

**ARTICLE I: NAME**

The name of this Fraternity shall be the University of Pittsburgh at Greensburg Provisional Chapter of Kappa Delta Rho.

**ARTICLE II: PURPOSES**

The primary purpose of the Fraternity shall be the promotion of good fellowship among its members and the advancement of truth, justice, and virtue.

The Fraternity shall provide a source of identity and dignity for each of its members. The Fraternity shall provide a significant force in preparing its members for the challenge of the future. The Fraternity clearly recognizes the need for scholastic achievement, intellectual honesty, community service, and personal and group fiscal responsibility.

The Fraternity accepts the opportunity to contribute to the general education of its members.

**ARTICLE III: MEMBERSHIP**

**SECTION 1.** The membership of this Fraternity shall consist of actives, pledges, honorary, social and alumni.

**SECTION 2.** Honorary members shall consist of outstanding faculty members or other men of good repute elected by the active chapter and approved by the National.

**SECTION 3.** Actives shall consist of all undergraduates, fully initiated upon completion of all requirements set by the Fraternity and University.

**SECTION 4.** Pledges shall consist of prospective members awaiting completion of the requirements for initiation.

**SECTION 5.** Alumni shall consist of those actives of the Fraternity who shall have completed their work at the University of Pittsburgh at Greensburg or those who, due to personal reasons, have terminated their career prior to graduation.

#### ARTICLE IV: OFFICERS

- SECTION 1. President: The presiding officer of the chapter. He presides at all meetings, enforces the laws, and serves in the capacity of the general administrator. He makes all appointments to all committees with the approval of the Executive Committee.
- SECTION 2. First Vice-President: The Rush chairman. He presides over the duties of the President should the President not be able to complete his elected term.
- SECTION 3. Second Vice-President: The pledge educator. He has full responsibility for all pledges and directs the pledge training program. He supervises the testing of pledges on the material required. He serves in the capacity of the First Vice-President in his absence.
- SECTION 4. Secretary: The recording secretary of the Fraternity. He conducts all correspondence and keeps the minutes of all meetings in permanent form. He maintains all initiation forms and the Bylaws.
- SECTION 5. Treasurer: The treasurer of the Fraternity. He collects all fees and pays the bills, keeping accurate records of all money received and disbursed. He shall be responsible for preparing a budget for the forthcoming year subject to the approval of the membership.
- SECTION 6. Sergeant at Arms: The doorkeeper of the Fraternity. He receives the handclasps of all initiates before their admission to Fraternity meetings. He maintains all ritual equipment and the meeting room.
- SECTION 7. Chaplain: Chaplain of the Fraternity. He is in charge of all devotional exercises in which the Fraternity participates. Responsible for the Invocation before all Fraternity meetings.

#### ARTICLE V: ELECTIONS

Nominations will be held the second to last week of the Fall semester with a mandatory Transitional Officer's Retreat to be held over the Christmas Break. Each nominee is responsible for a one-minute speech concerning his future position. All nominations will remain open until the elections. All nominees must be paid up to date with the Fraternity. Upon completion of the elections, the President and the Executive Committee shall make new appointments.

#### ARTICLE VI: MEMBERSHIP REQUIREMENTS

- SECTION 1. Pledges: To become a pledge, each upperclassman to be considered must have at least a 2.1 QPA. Freshman requirements will be set by the Fraternity. All Rushees must be approved by a vote of the active members to become pledges by receiving no more than 1/7 negative votes.



SECTION 2. Actives: To become fully initiated as a full member of the Fraternity, each must have completed his pledge training and must meet all requirements set forth by the National Fraternity, the Chapter, and the University. They must also have completed all financial requirements, and receive no more than 1/7 negative votes from the active membership prior to initiation.

SECTION 3. Letters: Any non-Fraternity member wearing a member's Fraternity letters with their approval will result in a five (\$5) dollar fine against the member. Any following offenses will be enforced through the Advisory Committee.

#### ARTICLE VII: FINANCES

SECTION 1. All financial requirements set by the Fraternity upon its membership shall be proposed by the Executive Committee and approved by vote of the active membership.

SECTION 2. The treasurer will prepare a budget of income and expenses which must be approved by a vote of the active membership.

SECTION 3. All members dues must be paid within the first two regular meetings of each semester.

SECTION 4. Those who cannot satisfy Section 3 of Article VII must abide by an approved payment plan.

#### ARTICLE VII: MEETINGS

SECTION 1. Regular meetings of the active Fraternity shall be held every FRIDAY at 12:00 noon. Special meetings may be called by the President subject to the approval of the Executive Committee.

SECTION 2. At all regular meetings a chairman will be required to conduct business.

SECTION 3. The President may give permission for any active member to be absent from a meeting provided it is a reasonable excuse which is subject to the approval of the Executive Committee.

SECTION 4. Any member being absent from a meeting without permission shall be fined five (\$5) dollars.

SECTION 5. Any member being more than five minutes late for a regular meeting will be fined two (\$2) dollars.

SECTION 6. All regular meetings shall be invoked by group recital of pledge vows.

## ARTICLE IX: RUSHING

Because of the importance of all rushing functions, all members will be required to attend. All members means actives, and pledges. Those not present shall be fined five (\$5) dollars.

## ARTICLE X: COMMITTEES

SECTION 1. Executive Committee: Comprised of President, First Vice-President, Second Vice-President, Treasurer, and Secretary. This committee meets weekly to prepare the agenda for all chapter meetings. It prepares the chapter program for the semester, and deals with all special problems as they arise.

SECTION 2. Advisory Committee: Comprised of the President and two elected members which the membership feels are responsible and aware of the chapter's needs. This committee looks after the conduct of individual members and admonishes them publicly or privately when it is deemed advisable.

SECTION 3. The following additional committees may or may not be used: Pledge Education Committee, Social Committee, Rush Committee, Budget Committee, Scholarship Committee, Social Service Committee, Fundraising Committee.

## ARTICLE XI: AMENDMENTS

These Bylaws may be amended by a two-thirds (2/3) majority vote of all members. The purpose of the proposed amendment having been presented one meeting prior to its call for approval.



ADVISORY COMMITTEE BYLAWS  
as of 1-23-87

I. PURPOSE:

The purpose of the Advisory Committee is to look after the conduct of the individual members of the Fraternity and to admonish them publicly or privately when deemed advisable. The following are examples of misconduct which would be brought to the attention of the Advisory Committee.

CLASS 1:            -Unacceptable behavior as per chapter vote.  
(warning)           -Violation of Chapter of National Bylaws (eg., unpaid dues, poor scholarship, etc).

CLASS 2:            -Violation of civil law.  
(hearing)            -Violation of University law.  
                      -Any Class 1 violation that is not resolved.

II. PROTOCOL:

A. Notification of Class 1 misconduct may be given to the Advisory Committee by members of the Chapter or by any other concerned party. Upon notification, the Advisory Committee shall be responsible for 1 written warning to be given or mailed to said member(s) along with a copy of these Advisory Committee Bylaws. The matter will then be discussed between the said member(s) and the Advisory Committee Chairman -- the latter being responsible for a brief report to be reviewed by the Chapter. The Chapter will then vote to determine whether the issues shall be considered resolved or unresolved. If the issue is unresolved, then a formal hearing shall be scheduled.

B. Notification of Class 2 violations may be given to the Advisory Committee by members of the Chapter or any other concerned party. Upon notification of Class 2 violations, the Advisory Committee shall be responsible for 1 written notice and 1 verbal notice for said member(s) to attend a formal hearing with the Advisory Committee. The written notice shall be mailed along with a copy of these Bylaws at least one week before the scheduled date of the hearing.

If said member(s) is unable to attend the hearing, provided it is a reasonable excuse subject to the Advisory Committee approval, he must notify a member of the Advisory Committee at least 24 hours before the hearing. That member shall be suspended from all Fraternity functions, both business and social, until he has met with the Advisory Committee.

Failure to notify the Advisory Committee of absence from the formal hearing will result in the expulsion of that member from the Chapter and the National Fraternity.

### III. HEARING PROCEDURE:

The formal hearing shall be held privately, and above all, orderly. Disorderly actions will result in contempt, eliminating any chance of said member(s) defending or explaining his accused violation.

The hearing shall consist of five parts:

1. OPENING REMARKS BY COMMITTEE
  - A. The committee Chairman must read a brief, unbiased statement describing the said violations.
2. OPENING REMARKS BY MEMBER(S)
  - A. Said member(s) explains or defends said violation fully and truthfully in an orderly manner.
3. CROSS-EXAMINATION BY COMMITTEE
  - A. Said member(s) is open to a field of questioning by any member of the Advisory Committee.
4. CLOSING REMARKS BY MEMBER(S)
  - A. Said member(s) is asked to add his closing remarks.
5. ADJOURNMENT
  - A. Committee Chairman adjourns meeting stating that a hearing report will be reviewed by the Chapter at the next regular meeting.

### IV. HEARING REPORTS:

This report will be subject to the review of the Chapter and shall consist of three sections:

1. INVESTIGATION -A transcript of the hearing.
2. CONCLUSIONS -Each member of the Advisory Committee will submit a brief, written conclusion.
3. RECOMENDATION -The Advisory Committee as a Whole will submit a recommendation to the Chapter as to any action to be taken against said member(s).

### V. CHAPTER DECISION:

At the conclusion of the hearing report, the Chapter shall vote to determine any action to be taken.

- III. To establish an Alumni Corporation.
- IV. To acquire permanent housing.
- V. To improve communication between our Chapter and the University's faculty and administration

#### LONG-RANGE CHAPTER GOALS

- I. To increase community service.
- II. To increase Philanthropic activities and donations to charities.
- III. To be supportive to the University through service.
- IV. To improve scholarship and our overall QPA.

## SCHOLARSHIP PROGRAM

### ALL MEMBERS:

Test File: Tests that members submit from classes that they have previously taken.

Study Night: There will be a study night held once a week for all members. It is not mandatory, but all members are strongly encouraged to attend.

Briefings: At each weekly meeting, members will be made aware of all workshops dealing with studying, tests, etc., and again all members should be strongly encouraged to attend.

Members who fall below a QPA of 2.0 will be put on academic probation.

### MEMBERS ON ACADEMIC PROBATION:

- Study nights are mandatory.
- Workshops become mandatory.
- Must spend a minimum of five hours per week in the library.
- Members will still hold voting privileges at meetings, but will be required to pay in order to attend social functions.

### MEMBERS ON ACADEMIC SUSPENSION:

- Those on academic probation two consecutive semesters will be put on academic suspension.
- Those members on academic suspension will not be allowed to attend any social functions sponsored by the Fraternity.
- Members on academic suspension will still be allowed to attend meetings, but they will have no voting privileges.
- Members on academic suspension may attend pledge and rush activities, providing that there is no party in conjunction with the activity.

- \* Full-time members with the **HIGHEST QPA** during the past term will receive a fifty (\$50) dollar scholarship.
- \* Full-time members with the **MOST IMPROVED QPA** (cumulative) will receive a twenty-five (\$25) dollar scholarship.

### PLEDGE EDUCATION

"In room 14 of Old Painter Hall at Middlebury College three men gathered because that which was available in Fraternities did not satisfy them. They objected to the narrowness and cliquishness. These were young men who were typically idealistic. It is their ideals which have sustained and nurtured Kappa Delta Rho." This quote taken from the Pathfinder holds true to Kappa Delta Rho Chi Alpha Chapter. The men of our Chapter also felt it was time to develop an organization that superseded all other groups and clubs at the University of Pittsburgh at Greensburg.

Our Chapter found our pledge instruction to be a travel which challenged our dedication to the Fraternity's ideals and make each individual reach deep inside their soul to find the motivation to strive forward and reach our final goal: Chapter!

Our pledge program instills the same principles that originally drove us to become a Chapter: dedication, morality, scholarship, leadership and honor. Our pledges are expected to take their training period as seriously as their schooling. At the same time the grades of a pledge must not falter because of his pledging. This would only hurt the Chapter by its acceptance of a brother who is not mature enough to hold his scholastics at a level above average. From the first week of our pledge program the pledges are expected to "get involved." Our Chapter prides itself in leadership involvement in clubs on campus. To belong to other groups is a goal of all brothers, to bring our Chapter good campus exposure and ideals of others into the organization. Each members personal goals are taken into account and molded so that as a whole we can reach the pinnacle of our Chapter's goals. To reach our goals we ask only one thing of our pledges: To become brothers that will never surrender the ideals of the brotherhood, supersede the expectations of previous brothers, and to instill the same high standards into those who will follow them. Holding to these values there will be no limits to us! Why? Because we are men of Kappa Delta Rho!



### BRIEF OUTLINE OF SOCIAL PROGRAM

Our Chapter's social program is basically broken into three different types of social events. They are: Social Parties that are open to the entire University population; Selective Parties those that are for brothers and their dates to attend only; and Brothers Only Parties that are strictly for the enjoyment of the membership.

Some of the Social Parties that our Chapter sponsored were: the Pre-Beach Party, Semester Formals, "Finals Over" Parties, and the Toga. These parties are opened to anyone who attends our campus. Social and honorary members are included. These aid in establishing a social repore with U.P.G.

The Brothers Only Parties include such activities as: Movie Night, Poker Parties, Bowling Nights, Visitations to other Kappa Delta Rho Chapters, Scavenger Hunts, Cruise Parties. These activities help to increase the unity of the Brotherhood.

### PHILANTHROPIC ACTIVITIES

The following is a list of all major and minor philanthropics completed by Kappa Delta Rho on the University of Pittsburgh at Greensburg campus. Also included is a list of future philanthropics.

#### MAJOR:

- Raised \$200.00 for an area transplant patient by stuffing 25 guys into a telephone booth.
- Sponsored a PAJAMA-RAMA for the American Heart Association; \$66.00 was raised.
- Christmas caroling for OPERATION SANTA CLAUS, a fundraiser sponsored by a local newspaper to provide a meal and a stocking for needy families on Christmas Day; \$40.00 was raised.

#### MINOR:

- Sponsored a pie throwing booth at a campus picnic. All proceeds raised went to the University's pavilion fund.
- Helped out with a local church's kindergarden halloween party. Helped clean up and judge costumes.

#### FUTURE:

- A canned food drive on campus to help out a food drive sponsored by the Boy Scouts of America.
- Going to Columbia University to help KDR Brothers sponsor a 5K race for M.S. on a weekend in April.
