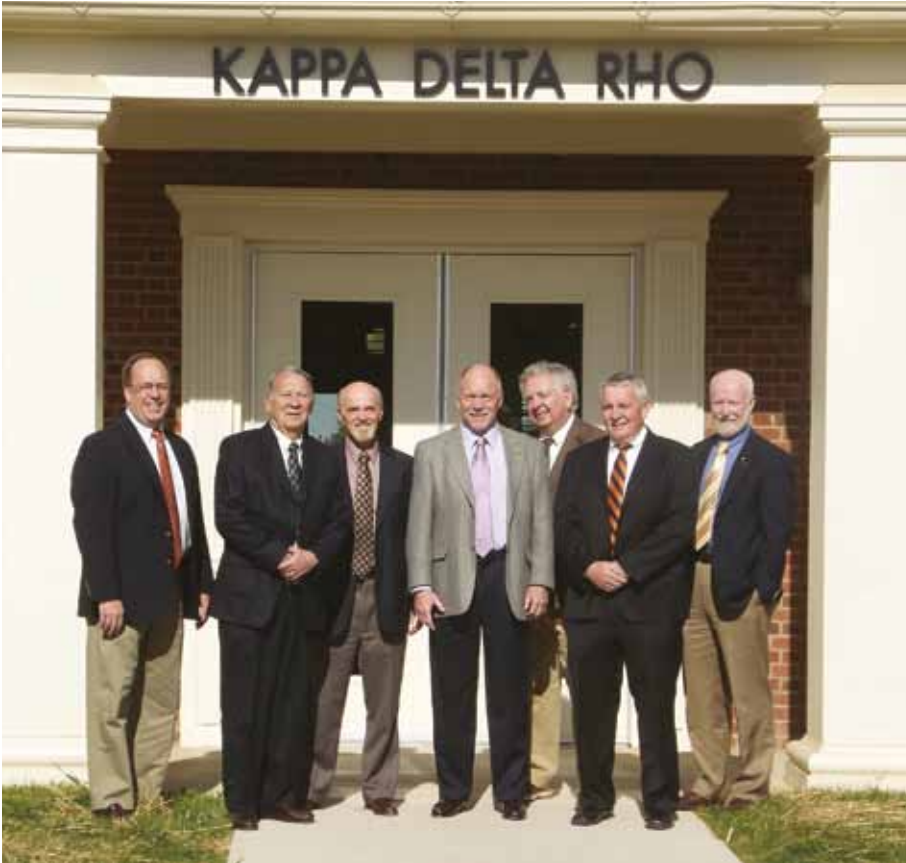

Why did I choose to join KDR?

For me, that's a complicated question. On the surface, it's easy to answer; my two best friends from my freshman hall group at Bucknell were very interested in KDR and I followed along. But the answer for me is much deeper. Rather than being just one of the crowd at Bucknell, I had a desire to connect with others who shared my values. To me, there was also something very compelling about an all-male organization, since I lacked strong male role models in my life up until that time. And that early connection to my hall mates Bill and Skip blossomed into strong relationships with many others such as Jay, Chuck, Harry, Mark, Ken, Tom, Bobbo, Ed, Neal, John, Frank, and a host of others. These guys represented KDR to me then, and when we were together, we were KDR! These Brothers formed an integral part of my undergraduate experience, and we shared a strong bond together. KDR contributed to the inspiration of our youth, and we engaged in all that she had to offer.

Why I am still involved with KDR?

At some level, it has been easy for me to remain engaged with KDR, as I returned to Bucknell for much of my early career. At first, I had many friends still in the Iota chapter. When they needed a campus advisor, it was easy to step up. As I began having a family, it seemed appropriate to disconnect, as those responsibilities were of a higher order. But, when the chapter ran into difficulty, it seemed natural to step up to those new challenges for the good of the Brotherhood. Over the course of 30 years, I was actively engaged in KDR for more than half.

About 8 years ago, my connection with the Fraternity changed with an e-mail message informing me that I had been nominated for a National award to be bestowed at the annual convention. I had never attended a convention even as an undergraduate, and I was impressed with the formality KDR had developed, with its commitment to tradition and ritual, and with strong sense of common values that came with an introduction to each new Brother I was meeting for the first time. Much to my surprise, the sense of mutual commitment and camaraderie extended quite naturally to my Brothers both young and mature. I remember first meeting Brothers Jon Kapell and Matt Lenno, being greeted as if we had known each other for decades. I also remember meeting with Shawn Hoke and telling him about my life's work (focused on leadership development, professional development and organizational development in higher education); this conversation likely led to an invitation to join the National Board of Directors a year later. During the development of our strategic plan, I "met" with a variety of Brothers through group meetings, personal interactions, emails, and survey responses, allowing me to understand how interconnected we all are.

The work of a Board member is demanding; the work of its officers is even more so. But with each day of effort, I find deep enjoyment and satisfaction that my work can help provide a Kappa Delta Rho experience to a greater number of young men who want something more in their lives and who sorely need opportunities for growth and-

development as leaders. KDR has much to offer these young men, and today I am proud to help in those efforts in whatever way possible.

In the next year, we expect to finish our groundbreaking new "total member educational program" called the Legion, to continue adding chapters and Brothers (currently up 17% over just 1 year ago, more than double what it was 6 years ago), and to add key positions to our staff. As president, I have one overarching hope for our work in the next few years. With all of the good things happening for our Brotherhood, I hope to invite and encourage more Alumni to find a way to become involved. As we have marched along life's journeys, we have all collected insights and wisdom that could be useful to our younger Brothers. By finding some way to assist an active Brother, encourage an active chapter, or support an Alumni organization, we Alumni can serve to strengthen all of KDR. There is much to do and the work is gratifying.

RISK MANAGEMENT POLICY

The Risk Management Policy of FIPG, Inc. includes provisions, which follow, and shall apply to all fraternity entities and all levels of fraternity membership.

IMPORTANT! Failure to comply with any of these provisions may result in a loss of any insurance coverage that may have existed.

ALCOHOL AND DRUGS

1. The possession, sale, use or consumption of ALCOHOLIC BEVERAGES, while on chapter premises, during a fraternity event, in any situation sponsored or endorsed by the chapter, or in any event an observer would associate with the fraternity, must be in compliance with any and all applicable laws of the state, province, county, city, and institution of higher education, and must comply with either the BYOB or Third Party Vendor Guidelines.
2. No alcoholic beverages may be purchased through chapter funds nor may the purchase of same for members or guests be undertaken or coordinated by any member in the name of, or on behalf of, the chapter. The purchase or use of a bulk quantity or common sources of such alcoholic beverage, i.e. kegs or cases, is prohibited.
3. OPEN PARTIES, meaning those with unrestricted access by non-members of the fraternity, without specific invitation, where alcohol is present, shall be prohibited.
4. No members, collectively or individually, shall purchase for, serve to, or sell alcoholic beverages to any minor (i.e. those under the legal "drinking age").
5. The possession, sale, or use of any ILLEGAL DRUGS or CONTROLLED SUBSTANCES while on chapter premises or during a fraternity event or at any event that an observer would associate with the fraternity, is strictly forbidden.
6. No chapter may co-sponsor an event with an alcohol distributor, charitable organization or tavern (tavern defined as an establishment generating more than half of annual gross sales from alcohol) where alcohol is given away, sold or otherwise provided to those present.
7. No chapter may co-sponsor or co-finance a function where alcohol is purchased by any of the host chapters, groups or organizations.
8. All rush activities associated with any chapter will be a DRY rush function.
9. No member shall permit, tolerate, encourage, or participate in "drinking games."
10. No alcohol shall be present at any pledge/associate member/ novice program, activity or ritual of the chapter.

HAZING

No chapter, colony, student or alumnus shall conduct nor condone hazing activities. Hazing activities are defined as:

"Any action taken or situation created, intentionally, whether on or off fraternity premises, to produce mental or physical discomfort, embarrassment, harassment, or ridicule. Such activities may include but are not limited to the following: use of alcohol; paddling in any form; creation of excessive fatigue; physical and psychological shocks; quests, treasure hunts, scavenger hunts, road trips or any other such activities carried on outside or inside the confines of the chapter house; wearing of public apparel which is conspicuous and not normally in good taste; engaging in public stunts and buffoonery; morally degrading or humiliating games and activities; and any other activities which are not consistent with academic achievement, fraternal law, ritual or policy or the regulations and policies of the educational institution, or applicable state law."

SEXUAL ABUSE AND HARASSMENT

The fraternity will not tolerate or condone any form of sexist or sexually abusive behavior on the part of its member, whether physical, mental or emotional. This is to include any actions which are demeaning to women or men including but not limited to date rape, gang rape, or verbal harassment.

FIRE, HEALTH, AND SAFETY

1. All chapter houses should meet all local fire and health codes and standards.
2. All chapters should have posted by common phones emergency numbers for fire, police and ambulance and should have posted evacuation routes on the back of the door of each sleeping room.
3. All chapters should comply with engineering recommendations as reported by the insurance company.
4. The possession and/or use of firearms or explosive devices of any kind within the confines and premises of the chapter house is expressly forbidden.

EDUCATION

Each fraternity shall annually instruct its students and alumni in the Risk Management Policy of FIPG, Inc. Additionally, all students and alumni members shall annually receive a copy of said Risk Management Policy.

BOARD OF DIRECTORS' SPOTLIGHT

The National Board of Directors is comprised of 12 Alumni Brothers, 3 undergraduate Brothers and the Executive Director. The Alumni Brothers serve on the Board of Directors for a term of four years while the undergraduate Brothers serve on the Board for two years. The undergraduate Brothers are slated and elected every two years, while the 12 Alumni Brothers are comprised of two groups of six, and are slated and elected in alternating elections. The slate is determined by the National Fraternity's nominating committee, comprised of the Past President, the Executive Director, and two Brothers at large.

To determine the slate, a call for nominations is placed in the Fraternity magazine *The Quill & Scroll*. The nominating committee reviews all of the materials submitted by Brothers who have entered their name into nomination, and decides which combination of Brothers would make the best slate of officers for the Board of Directors. They base this decision on the materials presented: the skills and experiences the individual Brothers could bring to the Board of Directors, and the needs of the National Fraternity. When Slate is determined it is communicated to the National President, and in turn is communicated to the Brotherhood prior to the National Convention.

At the 102nd National Convention the Brotherhood voted to approve the slate and installed the following Brothers as Board of Directors for the next two years:

VICE PRESIDENT FOR RISK MANAGEMENT AND STANDARDS, Scott Bradley, Zeta Beta '99

Brother Bradley has been in the mortgage business since 2001. Scott started working for World Savings as a loan officer dealing directly with the public. He was quickly promoted to an Account Executive working with and training mortgage brokers on World Savings programs. Scott spent a year and a half managing 6 account executives. Also, while working in the mortgage division Scott spent 4 years managing World Savings foreclosed properties. After being purchased by Wachovia, World Savings closed the broker division in October 2008. At that time Scott went to work for a mortgage company in Granbury to be closer to his family and to cut down on his travel. Though the company he has worked for has changed names a few times, he has been with Guild Mortgage since February 2010 as a Mortgage Banker.

VICE PRESIDENT FOR FINANCE AND ADMINISTRATION, Jon Kapell, Eta Beta '95

Brother Kapell supervises the Campus Activities & Involvement Center professional staff in their support roles for the SGA and student organizations at the University North Carolina at Wilmington. Jon is also responsible for hiring, training, supervising, and evaluating the Events Calendar Assistant and the Posting Assistant. In addition, he advises the Student Government Association, coordinates and implements the UNCWelcome Program, and oversees the UNC-Weekends initiative along with other staff in the division. Jon presents various workshops for the Organizational Leadership certificate and he serves on the campus as a UNCW Safe Zone trained Ally.

As an undergraduate Jon decided to join the Fraternity due to the men he met during recruitment period at West Chester University. The Brothers invited him to the house to watch football, all while being themselves

and not pretending to be people they were not. According to Jon “they answered all my questions and made me feel as though I was the only person that mattered. The Brothers left such a positive impression that he want to be part of such a great organization.”

When asked as an alumnus “why are you still involved with KDR?” Jon replied that he was given a wonderful opportunity as an undergraduate student and he wants to ensure that opportunity for future students. He enjoys volunteering to the national organization while still focusing on the individual needs of each of the members. According to Jon “as alumni we have a chance to make a future impact on our organization and we should not take that lightly. It is every Brother’s responsibility to help shape the future of our fraternity and it is a challenge he welcomes with open arms.”

VICE PRESIDENT OF EDUCATION, Matthew Lenno, Alpha Beta '95

Matt Lenno is currently the Director of Fraternity and Sorority Life at Towson University, a role that he has held since 2011. He is also the Vice President of Education for Kappa Delta Rho, and serves on the Board of Directors. Matt also serves as the NASPA Region II Fraternal Knowledge Community Representative. He has received three degrees from the University of Delaware (1995, 1996, and 1999): a B.A. in Biology, a B.A. in Philosophy, and a M.Ed. in College Counseling and Student Development. He is also a nationally certified TIPS Master trainer. After a short time as a social worker in the inner city of Baltimore, MD, Matt continued to work as a professional at the University of Delaware for eleven years. He worked for the Office of Residence Life, the Office of Judicial Affairs, and as the Assistant Director of Student Centers where he was the Advisor to Fraternity and Sorority Life for eight years.

While restructuring and utilizing the Chapter Assessment Program to educate and improve his chapters, Matt also developed, presented, and facilitated numerous sessions at over

50 college campuses. The various sessions included education on racial diversity and entitlement, LGBT issues, alcohol and date rape drug awareness, communication skills, risk management, leadership skills, sexual misconduct and Title IX, death and dying, listening skills, programming, suicide and depression, meeting management, anger management, conflict resolution, crisis management, assertive behavior, mediation, and community/group development. He has won numerous awards from NGLA, AFA, including the NGLA Advisor of the Year, the AFA Change Initiative Award and Diversity Initiative Award, the Award of Excellence from Health Communications Inc., and is also a recipient of the Ordos Honoris, from Kappa Delta Rho.

QUAESTOR, Peter Tartaro, Lambda Beta '00

Brother Tartaro is a December 2000 graduate of James Madison University, where he was initiated into the Lambda Beta chapter in the fall of 1996. As an active member he served as Consul, Senior Tribune, Pontifex and as an IFC Judicial Delegate and chapter representative. After graduating, Pete served with the national fraternity as a Programming Coordinator. Following his tenure with the fraternity, Pete began his career in financial services, working for Ameriprise Financial (then American Express Financial Advisors), which would see him promoted through two field offices and into a leadership role

in the corporate headquarters working with branch managers across the country. A two-year hiatus from the firm allowed Pete the opportunity to help active duty and retired military families engage in financial planning, followed by a year as a compliance supervisor. Pete returned to Ameriprise Financial in 2011 as a Regional Sales Manager, where he helped financial advisors as a business development coach; in December, he was promoted to Senior Manager - AAG Sales, where he leads a team of 8 Regional Sales Managers responsible for the entire employee financial advisor network.

I continue to volunteer, even as my own life evolves, because every KDR should have a similar experience.”

PRAETOR, Gerald L. Murray, Theta '68

Dr. Gerald L. (Jerry) Murray was born on March 28, 1944, in New Castle, Indiana and grew up in the small town of Spiceland, Indiana, where he still serves on the Board of Governors of the Spiceland Alumni and Former Students Association, the oldest organization in Henry County.

He graduated from Purdue University in 1966 with a B.A. in Social Studies Education. In 1968 he received his M.A. from Ball State University in Student Personnel Administration in Higher Education. He also earned an M.S. in 1978 from Purdue University in Industrial Psychology and his Ed.D. from the University of Virginia in Higher Education and Counseling in 1981.

He began his career in higher education at Ball State University in 1968 as an academic advisor. After several assignments and promotions he retired in June 2013 as Associate Director of Academic Advising and Associate Professor Emeritus. He had been active in University Senate for many years and chaired several university committees. He was a charter member of NACADA, the National Association for Academic Advising. Most recently he had served as national secretary of AD&D, the Association of Deans and Directors of University Colleges.

While at Purdue University he was a member of Theta Chapter of Kappa Delta Rho National Fraternity where he served as chapter president. Subsequently he has served on the Board of Directors of Theta Foundation, the alumni and housing corporation of Theta Chapter, since 1967—fourteen

years as president. He has also been a member of the National Board of Directors of the National Fraternity of Kappa Delta Rho, Inc. since 1974, serving as national secretary since 1988.

Dr. Murray is married to Sandra Murray, an elementary school teacher, and has two daughters; Abigail Slye and Andrea Murray. He lives in Daleville, Indiana, and is active in the Daleville United Methodist Church as chair of the administrative board, adult Sunday School teacher, lay speaker and delegate to the Annual Conference of the Indiana Conference of the United Methodist Church.

Gerald is past-president of the Muncie, Indiana, Optimist Club and past-president of the Central Indiana Old Car Club. He is an avid antique car collector and enthusiast and a 40 year member of the Rolls-Royce Owners Club of America.

DIRECTOR AT LARGE, Jonathan Boyle, Phi Beta '10

Brother Boyle was recently awarded a Ph.D. in Materials Science and Engineering from the University of Delaware. Jonathan’s research was on characterization of thin film materials for application in solar cells. The research was conducted at the Institute of Energy Conversion, which is the oldest university-based solar cell research center in the USA. His Master’s research was also performed at the University of Delaware and focused on characterization of quantum dot-based materials. Jonathan is an author on multiple publications and has presented his Doctoral and Master’s research at several conferences.

Jonathan attended the College of William and Mary where he earned a Bachelor’s of Science in Chemistry and Physics from the College of William and Mary. He was introduced to KDR by some friends who were Brothers within the Phi Beta Chapter. Members of the order will receive a certificate of recognition and acknowledgement in the *Quill & Scroll*.

The National Fraternity of Kappa Delta Rho utilizes Roman imagery & titles to reflect the stern Roman virtues to which our membership aspires.

This program is under the direction of Director of Fraternal Operations, Lauren Hopkins. We are pleased to announce that there are 324 undergraduate Brothers who received this distinction in our inaugural year of the program. Perhaps even more impressive is Kappa Delta Rho's organizational grade point average; currently, the average G.P.A. for a member of Kappa Delta Rho is a 3.03.

After addressing areas of improvement to assist our internal growth we developed an ambitious external growth program within our strategic plan as well. The plan focused on recolonization of key chapters that were closed; it also looked to develop new chapters that were either geographically accessible to existing chapters, or in the Southern and Western regions of our country. semester we chartered our third chapter in Texas at Angelo State University. Our Eta Gamma Chapter at Angelo State was another step in focusing on our growth South and West which is in line with the growth patterns of college undergraduates nationwide. In keeping with our commitment to recolonizations at key chapters that meet the criteria we have established for growth, we are in the process of recolonizing our Lambda Beta Chapter (James Madison University) and Omega Alpha Chapter (Virginia Commonwealth University). It is expected that

we will be chartering both of these chapters this upcoming fall semester. We also are currently working on preparing for recolonization efforts at Lambda Chapter (University of California at Berkeley) and Omega Chapter (Indiana University of Pennsylvania) during the 2015-2016 academic year. In addition we are in discussions with the administration at Lafayette College regarding a possible timetable for the recolonization of our Rho Chapter.

The men at the Lambda Beta Provisional Chapter are a great representation of the undergraduates we are attracting to the Brotherhood of Kappa Delta Rho. The grade point average of the Lambda Beta Provisional Chapter is above a 3.0; they have members involved in all facets of campus life, ranging from the band to student government, to athletic teams. Their Consul, Robert Sullivan is an exceptional student with a sharp focus on what the men of Lambda Beta need to accomplish this year. He is expecting that by the end of the academic year they will have grown to 75 men and submitted their petition for charter status to the National Board of Directors.

We are pleased to report the results of our hard work to expand of the undergraduate population within the National Fraternity is a growth rate of 134% (1,669) from our 2007-2008 level of 712 undergraduate Brothers.

This growth does not happen in a vacuum and can only occur with an exceptional staff trained in the concepts of dynamic recruiting and committed to expanding the Brotherhood. It is through the dedication of Brothers such as Daniel Brookman, Tau Alpha '07; Shane Henry, Zeta Beta '09; John Reynolds, Epsilon Beta '09; Bryan Field, Beta Gamma '11; Brad Ostermann, Beta Gamma '12; Ben Leahy, Beta Gamma '14; and Vaughn Emmons, Sigma '13, serving as Educational Instructors and doing the heavy lifting by recruiting exceptional student leaders to become Brothers of Kappa Delta Rho.

As a result of these recent successes, we have been able to increase our commitment to internal and external growth and hire for the first time a Director of Growth. This position is responsible for coordinating external growth of the organization, for working closely with those chapters with under 20 members to improve their recruitment and increase their size by 40%, and for simply being a resource for our other chapters to improve their own recruitment efforts. After a nationwide search we hired Kathryn Planow to be our first Director of Growth. Before joining the staff of KDR she was the assistant executive

director at Alpha Epsilon Phi Sorority and previously the Associate Director of Fraternity and Sorority Life at Longwood University.

Our goal is to grow the National Fraternity to have, sustain, and maintain at a high level of service 2,500 undergraduate Brothers within 50 chapters. This will require some hard work but we are confident that it can be achieved. It will raise the average chapter size of a chapter of Kappa Delta Rho to 50 undergraduates. We are not that far from this goal. We believe the key is to continue to live our values and recruit like-minded undergraduates who place honor above all things.

HONORING KDR'S CROWN JEWEL

ROBERT DONALD CORRIE, BETA '53 (1931-2014)

The candlelight dimmed within the halls of Kappa Delta Rho on the morning of October 20, 2014, when Robert Donald Corrie passed through the gates leading to Chapter Eternal after a brief illness.

For more than 58 years, he had served faithfully with 17 National Fraternity presidents and with seven Foundation presidents. He was a Brother who knew many of the original Founding Fathers; served the National Fraternity as a director, vice president, treasurer, *Ordo Honoris* chair, and director emeritus; supported the Foundation as a trustee, treasurer, and vice president of the Annual Fund; and advised the Phi Beta (College of William and Mary) and Beta Gamma (Christopher Newport College) chapters. He was a Brother who was honored with the Chapter Advisor of the Year Award on several occasions and with the prestigious North American Interfraternity Council Award of Distinction.

Brother Corrie was a rare KDR, who mastered a set of razor-sharp tools in the “workshop of the mind” where intellect and intuition generate success and build true character. Throughout his lifetime, he acted as a lightning rod channeling vigor and vitality to the energy grid fueling the Fraternity and the Foundation.

In 1959, six years after graduating from Cornell, Brother Corrie married the gem of his life, Ann Cameron. The durability of their marriage was celebrated this year with their 55th wedding anniversary. They were blessed to have three remarkable daughters, Suzanne, Jean, and Carolyn; two sons-in-law; three grandchildren; and two great-grandchildren.

He returned to Cornell University in 2013 for the first time since graduation where he felt at home strolling its labyrinth of pathways passing Willard Straight, Goldwyn Smith, and Morrill halls; McGraw Library; Sage Chapel; Cascadilla Hall; Beebe Lake; and Fall Creek Gorge.

One of his contemporaries remarked in 2010 at a roast given in his honor, that Brother Corrie possessed all the four “Cs” defining a perfect gemstone — precise **cuts** of personal and professional accomplishments that would rival some of the greatest thinkers and financial leaders; many **carats** of wisdom that were reminiscent of the philosophers of ancient Greece and Rome; brilliant **clarity** of vision and purpose; and vibrant **color** radiating from his bright, shining face, outlining his glittering eyes and serene expression.

Brother Corrie, as you take your journey home, we honor and bless you for your expressions of respect — honoring Kappa Delta Rho's timeless and sacred traditions, valuing humanity's tapestry of diversity, and teaching lessons of generous giving and open receiving — deo gracias . . . *Honor Super Omnia!*

Okay, so what's the Heritage Society? I'm glad you asked! The Heritage Society is the planned giving arm of the Kappa Delta Rho Foundation, which was established several years ago to provide a mechanism whereby Brothers could provide a meaningful gift to the Foundation and, in turn, the Fraternity upon their deaths. Perhaps, we don't like to use that term "death," but even KDRs are susceptible to its calling — just like taxes! During a Brother's lifetime, he can make a gift through his estate (will or trust), a 401k plan, retirement plan, life insurance, and a myriad of other methods. Planned giving is easy to accomplish, and later on in this article I'll point you to our website that will show you how in concise and simple language.

Today, the Heritage Society has more than 45 members and there are no dues, meetings, or other requirements for participation. Let me give you a couple of examples of what can be accomplished through a planned gift. Several years ago, a KDR Brother included the Foundation in his will — the amount at the time was unknown. Upon his death, however, the Foundation was notified by the estate that the gift was for \$5,000. This particular Brother had never given one cent to the Annual Fund of

the Foundation. At our average rate of return on investments, this gift will provide \$250.00 annually in perpetuity! *Our average annual giving for each Brother* to the Annual Fund doesn't approach that amount.

Another example is a Brother who has given the Foundation a \$25,000 paid-up life insurance policy that, upon his death, will provide an annual income of \$1,250.00 to the Foundation — *forever*. Income, after base expenses, from such gifts is then given to the Fraternity for its use in providing needed undergraduate programs and to fund a portion of its operating budget. In addition, the Foundation also uses a portion of these proceeds to provide annual scholarships to undergraduate members, which approaches \$80,000 annually.

As valued Brothers of Kappa Delta Rho, I urge you to consider a planned gift to the Foundation. It costs you nothing now and it provides substantial benefits for the continuation of our beloved Fraternity. 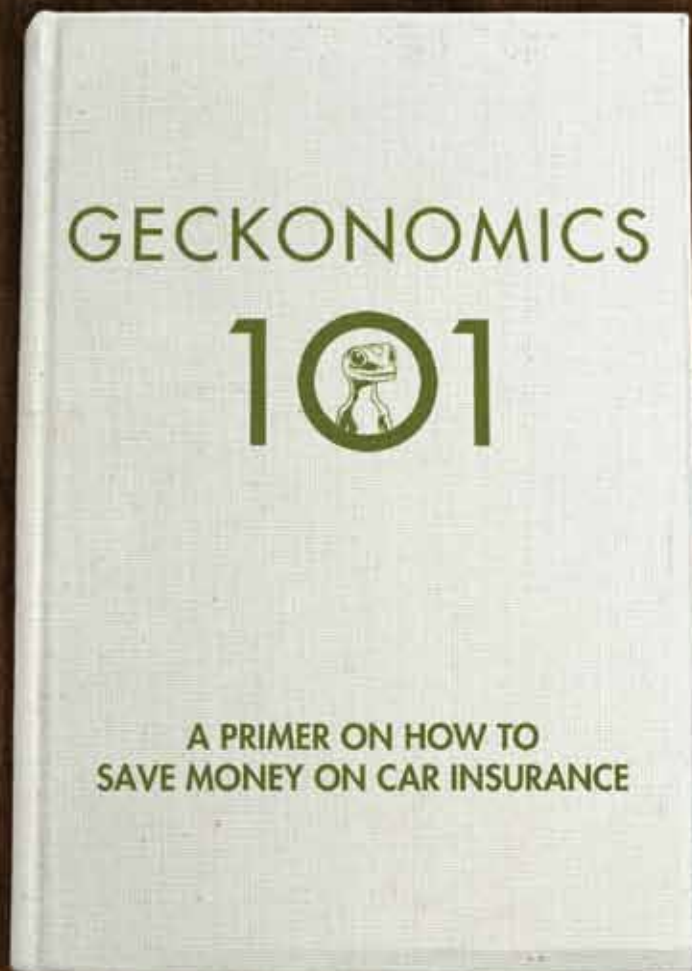
