You know how to plan a party!

When I returned to Clarion after convention, word spread across campus that I had been elected national president. For the most part, I received congratulations and well wishes from the members of the university and surrounding communities who found out, but the reaction of one of my colleagues caught me a little off guard. He said he thought it was great that I was national president, but he didn't understand why I was still involved with KDR after having been out of school for 10 years. I asked him if he is a member of a fraternity and he said that he was when he was in college. I looked him straight in the eyes and said, "You were Greek? What are you, dead?" Then he started mumbling something about how he is still a member and then quickly changed the subject.

After that conversation, I got to wondering, how many of our alumni say, "I was a KDR when I was in college." The thought that some of our initiated members may be walking around thinking, feeling, and talking that way really saddens me. I think that what my colleague really wanted to say to me was, "Come on Shawn, you're a grown man. You're married and you've got kids. Why in the world are you still involved with a college fraternity?" My answer to this question is simple. "Because I said I would." As initiated members of the National Fraternity of Kappa Delta Rho, we have all given our word that we will continue to support our Fraternity until we enter the Chapter Eternal. It's hard to put into words the feelings I experienced at the formal opening of this year's convention meeting, when all of those Brothers in attendance, from an Alpha alumnus from 1945 to the newest initiated undergraduate members, stood up together and reaffirmed their oath of membership.

You see, membership in Kappa Delta Rho is not a static thing. It's not a distant memory of good times gone by. It's not something you "were." Even if you can't get to convention or back to your chapter, participate in the ritual and formally reaffirm your oath, if you know what Honor Super Omnia means, then Kappa Delta Rho is part of who you are. I was speaking to undergraduate members at this year's convention and I asked them a simple question, "What does Honor Super Omnia mean?" Almost in unison they shouted out "Honor Above All Things." I said "No, that's what it translates to from Latin to English. What does it mean?" The room fell silent. I'm still involved with KDR because, as an alumnus, I get more out of my membership now than I ever could have imagined I would when I was an undergraduate. Kappa Delta Rho has moved from a group I belong to part of who I am because I have given a great deal of thought to what Honor Super Omnia means, I have taken it to heart and I try to incorporate it into my daily life. To me, Honor Super Omnia means "Do the right thing." What does it mean to you?

From the Executive Director

It certainly has been a monumental year for Kappa Delta Rho. During our Centennial year many chapters hosted events commemorating 100 years of Kappa Delta Rho. The Centennial Celebration was highlighted this past August at our National Convention in Baltimore, MD. This was my seventh National Convention, and I've never seen so many people leave as excited as I did in Baltimore. The event was an overwhelming success with hundreds of KDRs spanning generations and chapters in attendance. The convention, however, would have fallen short of expectations if we did not leave with a plan of action for the future of Kappa Delta Rho heading into our next century. With a sense of urgency in place, the Board of Directors, National Staff, and many of our volunteers left the convention with a distinct direction to take the Fraternity into the future.

With this direction in mind, the Board of Directors is working on an action plan for Kappa Delta Rho. Although aggressive in nature, this plan sets a very positive course of action for the future of the Fraternity. Many of the items interrelate and will allow Kappa Delta Rho to continue to be well-respected and a leader in the fraternity movement. I would like to highlight and share some of the items the board and various committees have been charged to work on.

The Education Committee has been charged to develop a comprehensive membership development program that, in addition to teaching new members about the history and structure of the Fraternity, will stress the values of the Fraternity and challenge all members to develop personally and professionally as members of Kappa Delta Rho. In today's environment, member education should not conclude with new member education. Member education needs to continue throughout one's involvement in the Fraternity and continue to add value and supplement each member's college experience. The goal of the comprehensive membership development program is to aid our members in development and education and give our members a leg up in the professional environment and in life when they graduate from college. Further development in our members will allow not only our members to prosper, but Kappa Delta Rho to prosper in turn.

The Alumni Affairs Committee has been charged to re-evaluate our current alumni programming model and possibly change the kinds of events we hold, from dinners and receptions to more family-oriented and multigenerational events. Furthermore, the committee has been charged with developing city and regional alumni associations to provide our alumni with more social, service, and professional development opportunities. A good example of an existing regional alumni association is the New Jersey KDR Association. Members who live in the New Jersey area can find out more about the alumni association and their events at www.kdrnj.com. In this issue of the Quill & Scroll you

will also find a survey to gauge your interest level in involvement in KDR. Please complete the survey and return it to the National Headquarters. When we were all initiated, we took a lifetime oath



to Kappa Delta Rho. As a National Fraternity we are committed to finding new ways to reach out to our alumni and keep you involved and engaged in the Fraternity.

In an effort to continue to help our active chapters, the board has created two ad hoc committees to address different means to advise chapters. The first committee will be made up of current and former chapter advisors in an effort to find ways to recruit, retain, and train onsite advisors for all of our chapters. Chapter advisors are critical to the long-term success of a chapter. They provide a mature influence on students as well as bring more seasoned life experiences that most college students don't have. The committee will work to assess the needs of advisors and continue to develop training models for new and current advisors. Additionally, a committee is being formed to review the Regional Senators Program that was in place a number of years ago in hopes to re-establish the program and give our chapters support from the National Fraternity in their regions in addition to the support the National Staff provides during chapter visits. The more support and guidance our chapters have on all levels, the greater the chance of long-term sustained excellence in our chapters.

In addition to working with our chapters on recruitment, finances, and chapter operations during visitations, the National Staff has been charged with developing a Chapter Assessment Program to act as a benchmark and guide to our chapters as to expectations for chapters of the National Fraternity of Kappa Delta Rho. This program will be based on a similar program developed by Brother Matt Lenno, Alpha Beta '95 (University of Delaware) and will provide goals and standards for chapters to reach in all facets of chapter operations. These include, but aren't limited to, academics, member education and programming, recruitment, chapter finances, social service, campus involvement, community involvement, alumni relations, risk management, ritual, and values. By giving our chapters stated expectations of Kappa Delta Rho chapters, it allows our chapters to have a guide to use in setting their goals and activities.

Finally, in a more esoteric initiative, an ad hoc committee has been formed to create a document entitled the "Precepts of Kappa Delta Rho." This document will act as a supplement to Credo, which was written by George Shaw, Alpha '10 (Middlebury College). The purpose of the Precepts of Kappa Delta Rho will be to provide a public document that reinforces the values of

Kappa Delta Rho as stated in our ritual. This document will allow the world to know what Kappa Delta Rho stands for and what it means to be a member of the National Fraternity of Kappa Delta Rho. Along with our motto *Honor Super Omnia* and our ritual, the precepts can act as a guiding light to our members across generations – as well as all active chapters and new members.

These items are only a part of the action plan that the Board of Directors is working on. Although it is an aggressive plan, I personally believe it is manageable and will help guide Kappa Delta Rho into our second century while building on a successful past and allow us to be even more prosperous in the future. It's an exciting and eventful time to be a member of Kappa Delta Rho — let's build on this excitement and charge into our second century!


LEADERSHIP CONSULTANT J.C. LOPEZ attend-

Building on the Successes of the Past

WILLIAM AND MARY'S undergraduate population stands at 5,500 students, with most fraternities tending to draw from the same pool of individuals. As such, we have needed a way to distinguish ourselves from other fraternities. Most rushees are acquainted with the achievements of our chapter and our Brothers on campus, but we have always found that giving prospective members an opportunity to meet brothers as individuals was our best option. "We've really worked to get rushees to become friends of individual brothers, who then introduced them to the chapter as a whole," states Patrick Walsh '07, senior tribune. "Our goal for recruitment is to have every Brother find and recruit one person whom he would like as a little Brother. By recruiting in this way, each prospective member has someone who is both a friend and a sponsor before the pledge period even begins." These strategies have allowed us over the past few years to transform our chapter from a small cadre of about 25 brothers into our current Brotherhood of more than twice that size.



What exactly is it that distinguishes us from other fraternities at William and Mary? Perhaps our alumnus Brian Ahnmark, '03, put it best, "When you look at William and Mary's sparse campus searching for diversity, where do you find it? Here, at KDR. Where else can an ardent Calvinist and an iconoclastic atheist sit down, argue furiously for two hours about their views, then smile and shake hands as Brothers?" Or, to borrow the simple words of neonate Ryan Bonnette, '08, "I just felt comfortable the very first time I came to KDR." That atmosphere of comfort and safety, often commented upon by rushees and guests, is engendered by all our Brothers. It comes from the attitude of respect and courtesy that we extend to each other as Brothers and to everyone else as guests and friends.

Certainly the successes of our past and our hope for the future do not rest entirely upon intangibles. The manner in which we interact with our campus and

KDR Penn State Perseveres Through Committed Leadership and Hard Work

Turning Adversity Into Opportunity

WE ALL KNOW the old expression about what to do when life gives you lemons. The men of Zeta Chapter know it a little better than most. In just one year, with the support of their alumni volunteers, they overcame tremendous obstacles to get their chapter back on track and thriving.

Following a fight with another fraternity during Homecoming Weekend 2004, Zeta Chapter was placed on provisional status. Thirty members of the chapter were officially placed on alumni status, meaning they were forbidden to participate actively with the undergraduate chapter. With a little more than 20 active members remaining, most of them freshmen and sophomores, the chapter banded together under the leadership of Consul Joe Flynn, '07, and set a plan in motion to rebuild and revitalize.

Below are just a few of their achievements over the past year:

 Reorganized the Executive Board and chapter leadership to set and enforce new standards for all members; held a summer retreat for leadership to conduct planning for the academic year.

greater community has always been one of our chapter's strengths. Three years ago, several of our members were pushing to increase our visibility on campus. This was accomplished by directing our time toward philanthropy and the service of others, in the form of supporting Up 'Til Dawn (UTD), an organization that coordinates the fundraising efforts of various groups on campus to benefit St. Jude's Children's Hospital. Our determination in the first year of participation led to UTD recognizing our chapter for raising the most money of any group on campus. The very nature of the UTD fundraising activities gave brothers an avenue for social interaction and an opportunity to better make our presence better known. Additionally, two Brothers applied for and received positions on the UTD executive board affording new opportunities for directorial experience.

In another recent example of the philanthropic spirit within our chapter, several of our service-oriented brothers wanted to help the Hurricane Relief Fund and did so by resurrecting the almost extinct KDRdiGras party. By throwing a Mardi Gras-themed party with beads distributed at the front door, we received more than \$360 in donations from guests and hosted a safe and enjoyable party.

Our presence on campus is not only limited to philanthropy. In recent years, the chapter has become heavily involved with the Council for Fraternity Affairs (CFA). This has allowed the chapter to craft Greek policy, interact with the College's administration, and lead the Greek community. Currently, two brothers sit on the council's Executive Board holding the positions of PR chairman and judicial chairman.

A great deal of credit for our successes belongs to those who have come before us. "Our alumni have been an incredible boon to our house," says Propraetor Michael Canestrari, '06. "Their first great contribution was the strong foundation of our young chapter, which they laid while they were undergraduates. The second is their incredible interest and willingness to help the house with everything from advice to physical labor. In certain ways our alumni have not changed since they were brothers—they still have all the drive and willingness to help that they did as undergraduates, only now they have more experience and better means to contribute."

Communication above all else is key to insuring strong alumni participation. In addition to traditional Email, mail, and meetings we have an alumni-moderated Yahoo group and even a recently created alumni group on www.thefacebook.com. For some of our most successful programs, such as our annual Career Roundtable and our new Alumni/Brother Mentoring Program, alumni immediately start galvanizing each other once the particulars of the event are set. We have come to count heavily on our alumni and they have always delivered.

Our policy and the seed of our greatest successes have always been to give brothers free range to explore and initiate projects that interest them. As former Consul BJ Gaessner, '02, once said, "If you have an idea, bring it up to the Brotherhood. If it seems like a worthwhile endeavor, we'll help you obtain your goal. Don't limit your achievements by limiting yourself." Based off Brother initiative and our past successes, the chapter hopes to continue its work in the field of philanthropy, Greek leadership, and success in the field of recruitment, and in so doing challenge ourselves to be better.

- Recruited 28 new members from fall 2004 to fall 2005.
- Achieved 3.0 cumulative brotherhood GPA for the previous two semesters.
- Organized the chapter's first-ever Community
 Day, an innovative project that included house
 tours and meet-and-greets for community members; the project received accolades from Penn
 State's Office of Fraternity and Sorority Life.
- Raised \$150K for THON, Penn State's major philanthropy event, placing fifth overall among fraternities; and added a new community service project through the local YMCA that partners active brothers with elementary school students for an after-school recreational program.
- Opened lines of communication with the National Headquarters, local alumni, and Penn State University Interfraternity Council through

weekly and monthly meetings.

 Received no point violations with the borough during the past year.

During the past year, Zeta alumni have rallied around the chapter, offering support, guidance, and motivation. At Homecoming 2005, the Alumni Board announced the public launch of a capital fundraising project to complete major renovations to their house. Alumni from '50s through the '90s complimented the actives on the condition of the house, their demeanor and their tremendous accomplishments.

A highlight at this year's Homecoming was the restoration of the stained glass windows that distinguish KDR from other fraternity houses at Penn State. They looked exceptionally bright, thanks to the sunny afternoon. If the past year is any indication, Zeta's future will be even brighter.



100 YEARS of KAPPA DELTA RHO



The celebration continued this summer in honor of 100 years of Kappa Delta Rho National Fraternity at the world-renowned Inner Harbor neighborhood of Baltimore, MD, during August 4–7 at our 94th National Convention and Elmon Williams Leadership Academy.

Excitement was upon all as undergraduates and alumni began to arrive and fill the Wyndham Hotel. With letters welcoming our Fraternity from President George W. Bush and Governor Ehrlich of Maryland, the roughly 250 attendees were ready to participate with pride.

Kappa Delta Rho's National President, Joshua Smith, Alpha Beta '93 (University of Delaware) welcomed the array of undergraduate delegates who represented their chapter and announced the commencement of the Leadership Academy. During the academy, undergraduate delegates took part in varying lectures by presenters, were introduced to fraternity and leadership topics, and had roundtable discussions. Among the keynote speakers were NIC Board of Director Rick Barnes who presented "Leading with Your Letters" and "Drink Think" as well as TKE alumnus Brian Bates of the Laurus Group who presented "Marketing 101: How to be Successful in Recruitment" and "What Alumni Want to Know", along with Ed King's presentation of "The Secret Thoughts of Ritual." Kappa Delta Rho Leadership Consultants A. McClain Clotfelter, Epsilon '04 (Franklin College) and Brian Graham, Epsilon '04 (Franklin College), worked with undergraduate delegates on a "KDR Ritual Workshop" and how to maintain proper communication with the National Office. Shawn Hoke, Phi Alpha '95 (Clarion University) also gave a presentation on how to correct apathy within the organization.

Throughout the academy and in between presentations, the undergraduate attendees were divided into smaller groups to converse on the topics that were covered by the presenters allowing for open discussions including important topics relating to Kappa Delta Rho, and leadership in all organizations. A well-rounded group of nine facilitators composed of Jon Kapell, Eta Beta '95 (West Chester University); Gerald Stebbins, Phi Alpha '88 (Clarion University); Wm. Scott Bradley, Zeta Beta '99 (Tarleton State University); Douglas M. Rammel, Pi Alpha '90 (University of Toledo); Peter Tartaro, Lambda Beta '00 (James Madison University); Ben Willis, Zeta Beta '99 (Tarleton State University); Matthew Lenno, Alpha Beta '95 (University of Delaware); Jorge Zapata, Zeta Beta '98 (Tarleton State University), and Chris Whitcoe, Alpha Beta '96 (University of Delaware) all provided excellent leadership as alumni facilitators. As facilitators, they were able to guide their groups on topics and initiate discussions, their contribution to the leadership academy was invaluable.

Alumni members and chapter advisors were also given the chance to attend and participate in **Alumni and Advisor Programming** during the convention. The seminar covered a variety of topics such as Housing Management, Recruiting Alumni Volunteers, Roles of Advisors, and Alumni Corporation Financial management. 
Alpha Gamma Chapter (University of Detroit Mercy)

Brothers,

Your Fraternity and Foundation have recently come off a very successful 100th Anniversary celebration in Baltimore, MD. To stop and realize that Kappa Delta Rho is 100 years young is truly remarkable. We now embark upon our second century of *Honor Super Omnia* and look forward to molding countless hundreds of future KDR's into community, national, and world leaders.

In our first 100 years we struggled as a national organization and envied our fraternity peers who seemed to have so much more in terms of resources than KDR. At the same time, however, we had truly great men and a leading reputation in the fraternity world. And, that reputation continues to this day. As important as it is, however, reputation alone is not enough in this day and age, as resources are an extreme part of the equation.

This was recognized by a group of dedicated KDRs in the early 80's and in 1984 the KDR Foundation was begun. Since then, we have worked extremely hard to create scholarships and financially assist the Fraternity with its many educational and leadership programs. Today, the Foundation is able to make grants to the Fraternity of more than 15 percent of its annual budget, but there still remains an annual shortfall in its overall operations. We simply have to do more!

In this, our Centennial year and at the Convention, the Foundation launched an aggressive and visionary program to endow permanently our existing programs, to expand into new program areas, and to offer support services not previously available. This campaign is known as the CENTENNIAL RECOGNITION PROGRAM and many of you have already been contacted by mail and telephone. Our goal is to raise \$2,500,000 over the next five years which should create an endowment stipend of \$90,000 - \$100,000 annually for the Fraternity.

All Brothers will be asked to consider their pledge of support over the next five years toward the success of this program and all who pledge at least \$500 will be permanently memorialized on a Centennial Recognition Wall that will hang in the National Headquarters. Our goal by the end of this year, December 31, is \$1,000,000 and I'm proud to announce that we've already reached almost \$700,000. 


