Leadership Conference and Sixty-third Annual Convention

THE 1974 NATIONAL LEADERSHIP Conference will be held in conjunction with the Sixty-Third National Convention of Kappa Delta Rho. Iota Chapter, Bucknell University, Lewisburg, Pa. will be the host Chapter. Registration will be on Thursday, August 22nd. The Leadership Conference will take place on Friday, August 23, and the annual Business Meeting of the fraternity (Convention) will be Saturday, August 24th. This is the first time since 1928 that Iota has hosted the National and everyone is looking forward to visiting the beautiful campus on the Susquehanna River about 60 miles above Harrisburg. For those coming by car, Interstate 80 passes within

10 miles of the site, and is the most direct East-West route to follow. Bucknell has the distinction of being the 100th College chartered in America. The college was founded in 1846 as the University of Lewisburg by the Baptists of Pennsylvania and New Jersey. The University was renamed in 1886 in honor of William Bucknell, a trustee and benefactor of the college.

The University is a co-educational institution, comprising a College of Arts and Sciences and a College of Engineering. Currently enrollment is about 3,000 students. There are 13 fraternities and 8 sororities located on the campus, and about 50% of the student body belongs to one of

the Greek organizations.

Thursday, August 22 will be devoted to registration of delegates as they arrive. Iota brothers will provide conducted tours of the campus, and we are trying to arrange a conducted tour through the Federal Penitentiary located in Lewisburg. Delegates and guests will be housed in Robert's Hall at Bucknell, and all meals, except the closing banquet, will be at the Chapter house. Meetings for both the Leadership Conference and the Convention will be held in the new University Center. opened during the past year. We are in the process of preparing an interesting program for the Leadership Conference, and we believe it will be

most helpful for under-graduates as well as alumni, especially those who work closely with an undergraduate chapter.

Alumni and undergraduates are encouraged to attend all meetings. A deposit of \$10.00 is required with each registration and the total registration fee is just \$25.00. This covers lodging and all meals for the three days, as well as the closing banquet Saturday.

For those who can plan attending the convention in connection with a vacation, there are many interesting nearby attractions. Bloomsburg, a few miles east on Interstate 80 has a transportation museum housing antique trolleys, cars, fire engines, etc. There is also a textile museum and a historical museum. The Carroll Park & Western R.R. operates a four-foot gauge steam train ride authentic to the era of 1860, out of Bloomsburg. Shamokin, to the southeast offers a 50 minute tour by mine train through a working coal mine. Reptiland to the North offers conducted tours where rattlesnakes are milked and alligators and other reptiles are shown. Piper Aircraft in Lock Haven (northwest) conducts plant tours Monday through Friday.

The National Sweetheart of Kappa Delta Rho

THE NATIONAL SWEETH EART of Kappa Delta Rho this year is the entry from Omega Chapter, Miss Christie Lynn Geuder, in one of the closest races we have had since the concept of chapter voting has been installed. Almost from the beginning of the voting, Rho and Omega were in a closely waged battle, and the outcome was in doubt up to the very last moment. In that your Editor could legally change the outcome by voting for his own chapter, he must abstain from casting any ballots whatsoever. The three votes permitted him are only to be used as a tie-breaking device, or to prevent a miscarriage of justice. His personal, unbiased opin-

ion is that the selection is a toss-up (and the vote very nearly bears out this contention). Christie, with 13 votes surpassed Roxann by only one vote. Several chapters split their vote evenly between the two candidates.

A Strange Coincidence

On MARCH 4TH Rho Chapter sent an Air Mail letter with a check enclosed to the National Office. Finally, on April 2, a duplicate check was issued and forwarded to the National Office. This letter arrived in Indianapolis on April 4, and believe it or not, in the same mail the original letter arrived with a penciled notation on the envelope: "Found in Air Mail Pouch at Monticello, Indiana 4-2-74".


This, in itself, is indeed a coincidence — both letters air-mailed one month apart, arriving at the National Office on the same day. However, on April 3rd, tornadoes hit many of the southern and midwestern states, and even continued into Canada. Unfortunately Monticello, Indiana was one of the communities hit hardest. About one third of the community was destroyed and several deaths and many injuries were recorded. Communications of any nature were cut off for quite some time until emergency units were set up. We cannot help but wonder when the first air mail letter from Rho would have been delivered if someone had not "found" the letter in an air mail pouch on April 2nd, the day before the tornado struck Monticello and adjacent communities.


KAPPA Ohio State University

Eventually two inmates, Bill Eubank and Roger Logue were allowed to attend regular classes at Lewis on a limited basis. During this time most of the members of KDR became very familiar with the inmates and learned to accept them as individuals instead of inmates.

Epsilon Alpha is proud to be the first to move in this direction and encourages other organizations and individuals to accept these prisoners as useful and productive individuals in our society.
