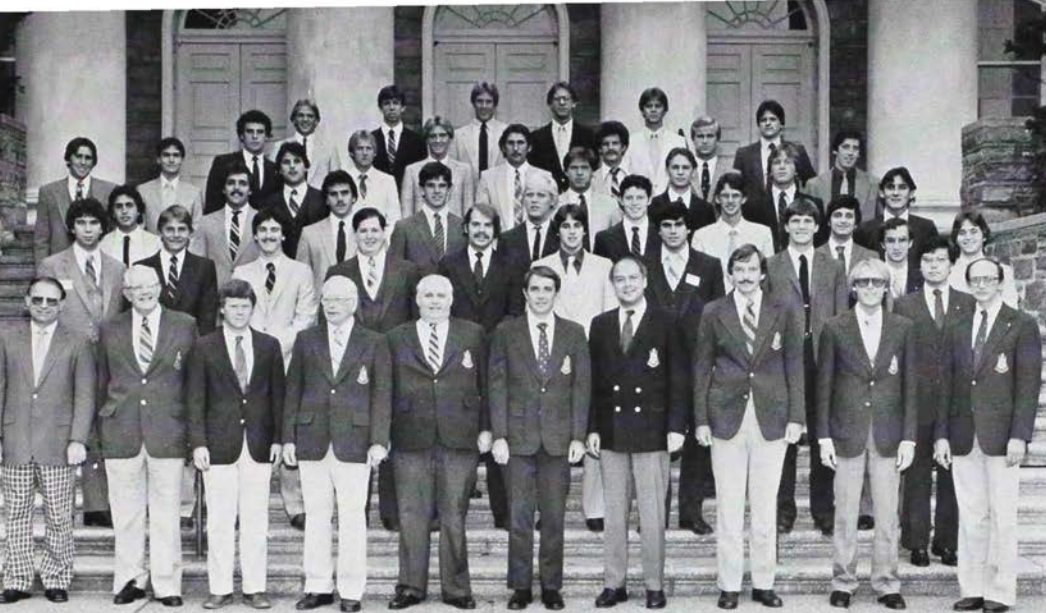

Conventiontime at Happy Valley



The morning of August 11th dawned gray and miserable with intermittent rain, creating havoc with well-laid plans for swimming and a picnic dinner at a nearby state park for registrants. But this was one of very few sour notes in an otherwise very successful leadership conference and convention that attracted a record group of alumni and undergraduates. For the remainder of the week the sun shone brightly and the weather was neither too hot nor cold.

The leadership conference extended through Thursday and Friday. After an opening welcome by President Robert Lynd, Jeff Fremont, assistant director of students at Penn State, discussed alcohol awareness and new member education practices with the delegates. Following a break, the group split into three committee meetings. One continued with alcohol awareness and the other two dealt with pledge training and national expansion. The afternoon continued with Robert Potter of the Stewart Howe Co., speaking about alumni relations. Committee meetings on scholarship, finances and budgets, and chapter improvements and goals completed the day.

After dinner at the Zeta house, a formal initiation of Chris Crabtree and D. Kirt Verhagen of Epsilon chapter was performed at the Eisenhower Chapel. This prompted a review of ritual and traditions instructive to all attending.

Friday's sessions began with Professor Leonard DeFabo of Indiana University of Pennsylvania, speaking on the psychology of professional presentations. His talk stressed the need for manners, correct dress and ways to present oneself to prospective employers. It was one of the best received conference messages. After a coffee break, this continued while two committee meetings (*Quill & Scroll* and Campus Involvement)

claimed some of the audience. The Great Fight, a dramatized version of how and how not to rush, led off the afternoon. Members of Zeta chapter assisted by little sisters made this one of the high points of the day. The official convention picture was taken on the steps of Old Main late in the afternoon. A short cocktail party at the chapter house preceded the Chapter Awards banquet held at the State College Elks Country Club. Brother Ofensend, *Zeta '54*, was the lead speaker, talking about what chapter involvement can mean to the individual in later years.

Saturday was devoted to the convention itself. As those of you who have attended past conventions know, this is strictly a business meeting with committee reports on most aspects of the fraternity. It provides an opportunity to speak out on controversial subjects, however, the 71st convention ran smoothly with remarkable harmony and was adjourned in mid-afternoon without incident.

The convention banquet was held that evening at the Nittany Lion Inn and was devoted to honoring the Hall of Fame recipients. State Senator Corman, *Omega '57*, welcomed the gathering in behalf of the Governor and the Senatorial district. Jack L. Anson, Executive Director of the National Interfraternity Conference, was the main speaker, elaborating on the future for fraternities. This was one of Jack's last official duties, as he retired in September.

"Ordo Honorium Fraternitas Kappa Delta Rho. Fratre, te salutamus."

So begins the citation awarded outstanding KDR alumni for the first time at the 71st conclave last August. "Brother, we salute you. Being persuaded of your honor, fidelity and concern for your fellow-man, we have caused these letters to be issued, under authority of the Board of Directors, at The Pennsylvania State University this 14th day of August in the year of our Lord 1982, and of the Fraternity, the 77th."

In our growing history as a national fraternity, we have from time to time recognized alumni for notable accomplishments and, where we have been able to ferret out the information, have written about notable KDRs in the *Quill and Scroll*. We have not, however, done these things in any formal way, and that we set out to correct with the founding of *Ordo Honorium*. The notion of a "Hall of Fame," while it carries with it the general idea of what the board wanted to accomplish, has also the less-desirable connotation of, perhaps, an annual prize for top sales producers. At best, the term is hackneyed and over-used. Instead, we looked to the tradition of the KDR Ritual and Ceremonies, based as they are on the model of the Roman city-state. *Ordo Honorium* was a distinction awarded to Roman citizens for their contributions to state and community, and was suggested to us by a Benedictine monk at the Archabbey of St. Vincent in western Pennsylvania.

Membership in the Alpha Class of Ordo was by nomination from chapter alumni boards, with final selection by the executive committee of the board of directors. Subsequent classes will be selected with advice from an advisory committee formed of Ordo members. In a concerted effort to avoid any bureaucratic encumbrances in the selection process, the criteria are simply stated in terms of accomplishment in career, community and, optionally, the fraternity. It is felt that KDRs worthy of the honor will percolate to the top, and that the alumni boards, Ordo and executive committees will recognize appropriate accomplishment when they see it. Interestingly enough, many of the nominees indicated in their

letters of acceptance that KDR had made an early impression on them which had lasted and which had helped in their development.

At the awards banquet pictured in these pages, we deviated somewhat from the order of selection in presenting the initial class. George Edward Shaw, *Alpha '10*, businessman, loyal Middlebury alumnus, community leader, and KDR for 70 years, lived a life of accomplishment whose details are known to any competent pledge in any chapter of our organization. The first, posthumous, award went to "Mr. KDR." The second membership was conferred on Otto S. Kirschner, *Beta '14*. At the age of 93, brother Kirschner is very likely the oldest active KDR alumnus and has the distinction of being a charter member of Beta, the founding of which made us a national fraternity. He has had one career as a teacher and two as a businessman, the latter having been started when he was past 60. Brother Kirschner lives on an island in the Puget Sound and, as I write this, he is on his way home from the 70th homecoming celebration at Beta, his second trip East in three months. Edward Mayer Maloney will have been a member of this fraternity for 50 years in June, 1983. Anyone having any association with us since about 1940 will know of our retired executive secretary, past grand consul and director emeritus. His wife, Betty, has also just retired from addressing, stamping and stuffing fraternity mailings and is well known to many of us. It seemed only appropriate that Mayer, with a lifetime of business, community and fraternity involvement, should become the third member of the Alpha Class of *Ordo Honorium*.

And so, a bit belatedly but nonetheless enthusiastically, we present the first from among our distinguished alumni, whose accomplishments should be an inspiration to our active members. The actives and pledges, after all, don't yet know what we alumni know: that some of the greatest experiences and benefits of KDR membership come after graduation.

Van Gorkom nominated by Reagan

President Ronald Reagan nominated Jerome W. Van Gorkom, Eta '39, as under secretary of state for management in September. The position was vacated when Richard T. Kennedy was named ambassador-at-large.

Van Gorkom is former chief executive officer of Chicago-based Trans Union Corp., a position he held 18 years. He is a director of the Schering-Plough Corp., Champion International, I. C. Industries and other corporations.

Active in Chicago civic affairs, Van Gorkom has served as chairman of the mayor's committee to study the troubled Chicago school finances since 1979. He is chairman of the board of the Lyric Opera and is a member of the University of Illinois Foundation.

After World War II Naval service, Van Gorkom was associated with a Chicago law firm, specializing in federal tax law. In 1947 he joined Arthur Andersen and Co., certified public accountants, and he became a partner in the firm in 1954.

He joined Trans Union in 1956 as a controller and within seven years rose through the ranks to the presidency.

Nu chapter honored

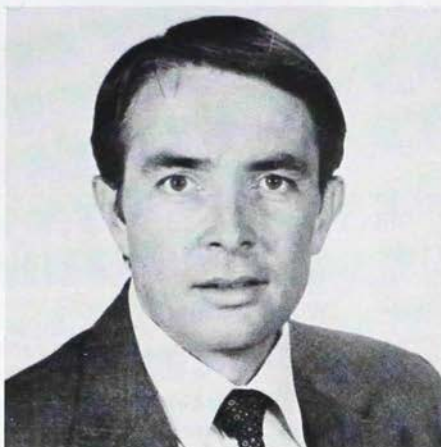
Indiana University's IFC has informed us that Nu chapter has received honorable mention for the Grand Chapter Award for the academic year 1981-82.

Alumni Fund

Eight weeks into this year's campaign finds the Alumni Fund at \$13,018, or 43 % of the campaign goal of \$30,000. Bob Corrie, Beta '53, chairman of the Alumni Fund Campaign, reports that we are 20 % ahead of last year's campaign at the same date and that if the momentum continues, we should easily surpass the campaign goal set by the board of directors this summer. With 469 contributors, we are somewhat behind the goal of 550 contributors which we had expected to achieve at this point in the drive.

At this date, Beta chapter (Cornell) leads in dollars of contributions with \$1,400, and is followed closely by Eta chapter (University of Illinois) with \$1,367, and Theta chapter (Purdue) with \$1,365. In fourth place we find Lambda chapter (University of California) with \$995, and in fifth place we find Nu chapter (Indiana University) with \$870. Last year, Kappa chapter (Ohio State) was the top chapter in dollars contributed, due to the beneficial effects of a challenge

grant. Beta and Theta chapters are tied for first place in numbers of contributors, with 40 each, and are followed closely by Eta chapter with 39 contributors. Nu chapter is in fourth place with 34 contributors while Lambda (University of California) and Rho (Lafayette) are tied for fifth place with 33 contributors each. Last year's final winner was Lambda chapter with 91 contributors. Based on the influx of contributions in the last few weeks, Lambda chapter may overtake the current leaders by the end of December.

Your contribution is needed today if Kappa Delta Rho's progress to date is to continue. Last summer's outstanding convention, this year's installation of five chapters culminating with Gannon in early November, and the aggressive calling program recently instituted, require support.

Please make use of the coupon on this page to keep the momentum going. There was a significant drop-off last year when a report similar to the above was published, and while the fund appears to be doing well, efforts must continue to avoid any feeling of complacency.

NU '51—Wayne L. Tash, judge of superior court No. 2, Wayne County, IN., on March 28, 1982.

GAMMA '49—Clifton C. Thorne, a teacher and administrator at the State University of New York through most of his career,

passed away April 12, 1982. He taught business from 1952-1959, then served as director of graduate studies, dean of men, dean of the University College, dean of students and vice president for student affairs (1965). After six years in that post he was named vice chancellor for the state university system. In 1976 he was named president of Blue Cross (Northeastern NY). 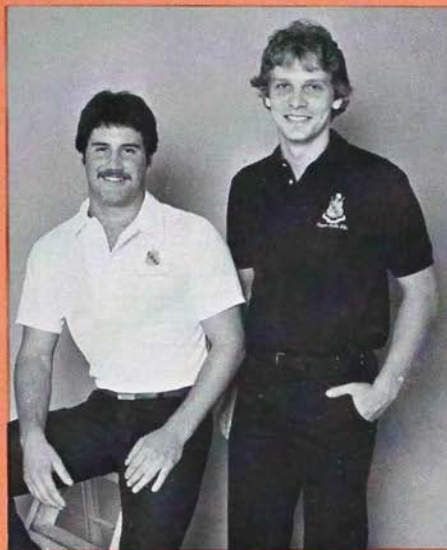
Grand Consul's Award
