VIEWPOINT

Despite our best efforts, hazing is again prevalent throughout the college fraternity system. Since 1978, more than fifty students have died in tragic hazing-related incidents with alcohol being prevalent in most cases. Although in its 83 years, Kappa Delta Rho has never experienced such a senseless tragedy, we have recorded minor incidents. It is even with these minor incidents, we must hang our heads with shame and wonder if our fraternity will be the next to experience a hazing-related death.

The highest human values enunciated in our ritual and creeds have been pushed into the shadows and forgotten in the newest wake of a misdirected and senseless pursuit of "fun." This pursuit of fun has not only led us to be social directors for the entire campus, but returned our members to using others as a useless means to an end. It is amazing how not only our undergraduates, but some alumni still argue that this sub-status membership category builds a stronger and better prepared individual. I could support the belief in this category if I knew that hazing was eliminated and our educational programming was instituted in total, but I am sorry to say this is not true. Our new members, in many cases, are not being educated properly by those in charge as to their responsibilities of our fraternity.

Again, under the guise of a "pursuit of fun," let us look at how this has affected our image. Because of hazing and alcohol-related problems, fraternities are now rated among the ten worst risks by the insurance industry. Some national fraternities have found coverage unavailable, while the insurance costs have skyrocketed for those fortunate in obtaining coverage. Such television programs as "Donahue" and "Gerald" join Time, Newsweek, and hundreds of other publications delivering the same sad message.

Fraternities operated for more than 100 years before the pledging practice was adopted.

It is also because of these same problems that many colleges and universities are now telling us we no longer have anything to contribute to the pursuit of higher education. Can our entire system stand honestly to this test when, as an example, we know in addition many of our chapters are below the all-mens campus average?

Over 30 years ago, the fraternity system, through the National Interfraternity Conference, banned hazing from its system. All National fraternities have instituted strong sanctions resulting in hundreds of chapters being closed for improper new-member activities. Over the years, thousands of fraternity leaders, campus administrators, alumni volunteers, and undergraduates have been orientated to these problems and trained to eradicate this cancer from our system.

It should be noted here that the greater majority of our members and fellow Greeks of all ages support the elimination of hazing, but, as always, there are a few who continue to stoke the old fires. It is because we all have this misdirected few that we must recognize the potential for tragedies to continue. As long as this "potential" does exist, the only solution must be a revolutionary change and this change must come from within, while we still have the privilege of directing our future.

Before we continue to address the need for a change, however, we must first accept the fact that "WE HAVE FAILED." Once we have accepted this fact, that our system is not flawless, we will be able to wholeheartedly approach the problem.

Hopefully, having accepted that we have failed, we can now move on to discussing this change and this change is as recommended by other leaders of the fraternity world — a return to what once was. By this, I mean the elimination of the associate members, or pledge status from our system. As a point of information, fraternities operated for more than 100 years before the pledging practice was adopted. In reality, what I support is not a change, but merely a return to the roots of our fraternal system.

HONORED ALUMNUS

Providing a legacy for future generations can represent sharing a gift we received. Too often the collegiate fraternity environment is perceived only in a social setting despite the fact that fraternity life can be an important supplement to any undergraduate education. I want to help sustain the education opportunities of fraternity life, particularly those offered by KDR.

Fraternity life reinforces the importance of accepting responsibility and consequences of individual decisions. The custodial care of dormitories is not a part of fraternity life; the fraternal collective must live with the consequences of fraternity house use. The brotherhood is forced to set policies and select leaders to administer according to the group conscience; and the collective begins to create favorable circumstance rather than to be victimized by circumstance.

The political and management laboratory for learning begins with a rushing selection of compatible personalities. This selective process, often criticized by academicians, fosters mutual respect within the group, far more so than in dormitory life or among academicians. Mutual respect is, in my opinion, one of the most important lessons of life for anyone to accept without any reservation whatsoever.

Mutual respect is one of the essential requirements for leadership within any group of peers, to obtain results through other people that enhances the quality of life among people served by the group. The opportunity for leadership experiences must be broadly distributed on any campus to fulfill the broad education goals of any undergraduate program. Fraternity life undeniably contributes importantly

towards such fulfillment.

Many KDR alumni can trace some of the roots of their accomplishments back to fraternity learning experiences, including memories of sharing good times with others. For each, this educational gift was made possible by so many predecessors wanting to share the gift with future generations.

Leaders in today's society are but servants of people. They work to earn money, but like everyone else, have never been made truly happy by it. Through failures and successes most alumni eventually realize that good feelings about our lives depend importantly on how much we are able to help other people through our business, governmental, educational, or religious activities. To many, it has been astonishing that anyone can make a meaningful contribution towards enhancing the quality of life for many people. This is the essence of success, not money nor pride.

I founded several multinational companies which, without external financing, grew to command considerable respect and influence. People mistakenly think that I am some kind of management expert. Yet when asked about keys to corporate success, I reply with surprising assuredness on several points. One is mutual respect within but one peer of the corporate group. The other deals with granting of employee stock options; my general advocacy is not currently thought to be absurd as it once was: the smaller my ownership share, the larger my personal wealth. I am only one of many entrepreneurs who have demonstrated the validity of this point, which underscores the fact that desired results are achieved only through other people.

The Army taught me, as an officer, to

be first on the firing line and last in the chow line; if you serve your unit well, your men will serve well under you. Somehow at the end of the day, serving others comes back to each of us in a rewarding context.

I elected to serve my fraternity not to pay back on a gift; for, this I cannot possibly do. But I have offered to help and serve our fraternity knowing that there is no better feeling than that of trying to help others when asked. It is said that we each shall reap what we sow. Such as stewards or servants must never be in search of reward; for it is the helping of others which is by itself reward and success, generated by realization that we are of value to others.

Our National Fraternity, on August 14, 1982, honored me as an outstanding alumnus. If the honor given me provokes new thoughts to rejoin our common cause, then it may serve a worthy purpose even though the honor may not be fully merited.

Brother Jones is founder and Chairman of MMS International, Market News Service, and the International Institute for Economic Advancement. In addition he was previously active in the public sector as a Mayor, with numerous appointments to State and County Committees, often as chairman. In 1982 he was selected because of his accomplishments as a member of the Alpha class of Ordo Honorium.

The International Institute for Economic Advancement is a non-profit corporation funded by Jones to create an international consortium of economists and political scientists to create and implement policies that foster international trade, economic cooperation, and enhancements to global living standards.


The Institute has the first-ever joint research agreement with the USA Institute of the Soviet Academy of Sciences. A recent public conference session between American and Soviet delegations was recently tapped for public television distribution late this year.

Brother Jones has been asked by the Soviet government to give management lectures to factory directors throughout the Soviet Union next May. The Soviet objective is to encourage re-structuring Soviet enterprises after the employee ownership and management plans Jones used to develop his companies.

ABC 20/20 Television show is planning to do a segment of Brother Jones' ability to manage worldwide enterprises from his remote office high above Lake Tahoe. Filming was scheduled for November 14. The accompanying picture of the view for his office will help explain why ABC News became interested in how telecommunications have changed executive lifestyles.

It is with appreciation that the family of Kappa Delta Rho sincerely thanks Brother Jones for his outstanding contribution of \$50,000. It is through this contribution and direction that the "Challenge Fund" was established in conjunction with the Foundations 1988/89 Annual Alumni Campaign. Because of his generosity and sincere desire to sustain the educational opportunities of our Fraternity, \$25,000 will be allocated from his contribution to fund new scholarships.

Without question, because of his dedication, Kappa Delta Rho can truly say "This is my son."

A Message From The Past President

KDR has come a long way since that day over 25 years ago when I first learned of this organization. In those days, our presence was limited mainly to a cluster of chapters in Pennsylvania and New York, a scattering in the midwest, and a couple of outposts on the West Coast. Since then we have tripled in size, moved into the south and southwest, and revived several long-dormant locations. This success is the result of hard work by hundreds of KDRs nationwide; however, thoughts of some key players remind me of the remarkable difference just a few people can make. And I remember several (in more or less chronological order) who have made lasting differences in KDR:

- **Floyd Baughman**, national president in the early 1960s, who modernized our structure and brought current corporate management techniques into the organization.

- **Executive Secretary Lawrie Barr**, an enthusiastic idealist who first taught me and an uncertain group of undergraduates what the fraternity idea was all about; who stayed in the job on a part time basis to keep the national organization afloat when professional and personal demands left few spare moments.

- **John Padget** — an articulate Harvard MBA — the picture of what a national president should be, who laid the groundwork for the strong organization we would need to see us through the late 60s and 70s.

- **Charlie Beck**, whose years of singular devotion to the *Quill and Scroll* gave us a source of stability through years of change and upheaval.

- "Mr. KDR" himself — **E. Mayer Maloney**, a no-nonsense Hoosier businessman with an ever-present warm heart and kind word. After serving as national executive secretary in the 40s, national president in the 50s, and chapter advisor for eons, he returned to service in a second term as executive secretary at a time when KDR very much needed him. His remarkable organizational abilities allowed us to weather the terrible 70s decade virtually unscarred, at a time when other nationals were being decimated by anti-traditional trends.

- **Ken Gesner**, a man of wide organizational talents who has contributed in so many capacities — as national director, vice president, president, foundation director, insurance advisor and constant source of unflappability, optimism and common sense.

- **Bob Corrie**, who built our annual fund drive from virtually nothing to a six-figure campaign and whose dedication for over 30 years as treasurer, vice president, foundation director and financial advisor have been just a small part of his contribution to our organization — with the other part being the goodwill and warm friendship he imparts to all KDRs.

- **Jim Edgeworth**, our new national president, who is already breaking ground in the area of alumni involvement and new fund raising approaches.

- **John Carl**, who brings years of experience as a dedicated corporation officer and more recently as advisor to a new chapter.

- **Scott Bailey**, who is steadily guiding the revitalized KDR Foundation on a successful path.

- **Bob Jones**, who has given us a new and challenging view of what KDR and its foundations can become.

- And in a class by himself — **Don Stohl**. There is no one who more exemplifies the difference one person can make. In the early 80s, KDR had about 15 chapters — and several of them in shaky status. We now approach the 90s with fifty chapters close in sight, with limits we once thought unpassable now far behind. Don has shown us it can be done, and more than anyone has reminded us of the importance of believing in ourselves.

I thank all these friends and people like **Ed Hoffman**, **Rich DeBernardo**, **Dick Nolan**, **Mike Howard** and so many others who could be mentioned for the wonderful experiences and lessons thus far. I look forward to KDR's future with excitement and optimism. I urge all of our members to join with us in the friendship and fun. Get in there and *make a difference!*

They came from the North, South, East, and West, from small towns and large cities alike, but they all had one thing in common; each and everyone a brother of Kappa Delta Rho. The scene was set for the 77th Annual Convention and Leadership School of Kappa Delta Rho National Fraternity, held outside Chicago, Illinois, at the Hyatt Regency Woodfield.

National President, Robert D. Lynd, welcomed the largest undergraduate delegation ever assembled in the Fraternity's history, and officially opened the 77th Annual Leadership School and Convention. President Lynd then charged to the delegates, "The State of the Fraternity."

Executive Director, Donald L. Stohl, and Executive Vice President, James F. Edgeworth, Sr., conducted a presentation on National Policies and Procedures. They stressed the importance of getting pledge and initiation forms and fees in on time to alleviate any unnecessary problems or delays. The two made it very clear that there will be no more outstanding bills owed to National by the undergraduate chapters if everyone complies with the Policies and Procedures.

Throughout the afternoon, workshops were held including Thomas Devine of Sigma Alpha Epsilon, speaking on the topic of budgets and filing 990's, which was to the enlightenment of all Chapter Quaestors in attendance. Brother Steve Bennett, Eta Alpha '89, concluded the afternoon with a presentation on IFC involvement and the importance of our undergraduates taking an active role in their individual IFC on campus. Steve was not only the President of the IFC at his campus of Robert Morris, but presently serves as Executive Vice President of the Northeastern IFC.

Friday morning marked the arrival of KDR alumni from all over the country. President Lynd welcomed all alumni and charged to them, "The State of the Fraternity." The alumni witnessed a full day of workshops with Tom Devine discussing the Role of the House Corporation, Building a Working House Corporation, Financial Management, and Options and Planning and Goal Setting. A group of enthused alumni emerged from these presentations feeling more knowledgeable and ready to help their own chapters become stronger in the future.

Friday morning came early for the undergraduates, as Tom Devine started their day with a workshop on Chapter Long-Range Planning. Vice President/Development, Bob Butler, Zeta '87, then gave an enthusiastic presentation on Pledge Education, "It's Everybody's Business." The delegates conducted an excellent question and answer session with Brother Butler expressing concerns along with new ideas pertaining to pledge education. The Executive Director of the NIC, Jonathan Brant, took over the spotlight and presented INTERCHANGE, a program designed to help campus IFC's take part in an evaluation program which will boost the organization and efficiency of the Interfraternity Councils across the country.

A panel luncheon entitled "Are WE Going to be Around?" featured four very worthy guest speakers. The speakers included Jonathan Brant, Executive Director of the National Interfraternity Conference (NIC); Charles White, Managing Director of Sigma Phi Epsilon, and President of the Fraternity Executives Association (FEA); Michael Schermer, Sigma Tau Gamma, Director of Student Life at Illinois State University; and Brother Raymond Eddy, Dean of Students and Coordinator of Greek Affairs and Special Programs for the University of Delaware. Following the presentations, was a very informative question and answer session.

Following lunch, the undergraduates attended a Public Relations/Rush Workshop hosted by Ted Priebe of Alpha Gamma Rho Fraternity. The importance of good public relations was stressed, and creative ideas on rush were exchanged. The undergraduates then split up and attended three separate workshops, in which each group would move on to the next workshop every fifteen minutes. Brother William Paris, Eta '87, conducted the Pre-Initiation Ceremonies Workshop, Nancy Olenick of Party Smart discussed responsible drinking, and Brother Raymond Eddy stressed the importance of scholarship.

Alumni and undergraduates came together for a presentation on Risk Management and Insurance Program with Charles White, Executive Vice President, Sigma Phi Epsilon, and President of the Fraternity Insurance Purchasing Group. This very serious topic was discussed in depth and many brothers were given an opportunity to air their views and have questions answered.

Friday evening proved to be very special for all in attendance. An initiation ceremony was held, and Kappa Delta Rho National Fraternity welcomed two new honorary members. William C. Benton of Naperville, Illinois, and Vernon R. Miller of Plymouth, Indiana, joined our brotherhood. This was an opportune moment for undergraduates and alumni alike to reflect and remember why we joined Kappa Delta Rho, and remind ourselves of the values and standards she stands for.

Saturday featured a full schedule of events. The 77th Annual Convention of the National Fraternity of Kappa Delta Rho, Inc., was called to order by Grand Consul, Robert D. Lynd, at 9:30 A.M. Delegates representing 30 Chapters, 6 Provisional Chapters, 1 Group of Intent, and 23 Alumni Corporations comprised the largest Convention attendance in history.

The always exciting Awards Luncheon was next on the agenda. Numerous individual and chapter awards along with scholarships were presented. A highlight of the luncheon was the traditional ceremony honoring those standing members elected to the Consul's Advisory Board. A rundown of all the winners appears in the following pages.

Eileen Geraghty, the Youth Programs Officer for the U.S. Committee for Unicef, conducted a workshop concerning our National Philanthropic Projects. Eileen educated the delegates about UNICEF and proposed ideas to raise money for the project. It is the hope of the National Fraternity that all chapters will take part and make our National Philanthropic Project a success.

It was Saturday evening, and only one event remained, but the best was definitely saved for last. This year's Ordo Honorium Banquet once again topped the previous years. An extravaganza which none of those in attendance will soon forget was filled with individual honors and the presentation of our new Grand Consul. A full account of this historic occasion can be found in the pages ahead.

The 77th Annual Leadership School and Convention was now history, and only the knowledge acquired and the fond memories remained. Once again, KDR's both young and old, from across the country had come together for a common cause, KAPPA DELTA RHO. This convention marked the largest ever, and 1989 in Richmond promises to be even better.

Majoring in Finance, with a Quality Point Average of 3.2 on a scale of 4.0, Brother Sarson has excelled on the Penn State Campus as a leader in the Greek world. Matthew has served his I.F.C. as the University Relations Chairman, Interfraternity Representative for three years, Skull and Bones Honor Society, (the most selective honor society on campus), and the Order of Omega Greek Leadership Honor Society. He has also been active with his chapter of Kappa Delta Rho serving as Rush Chairman, Dance Marthon Philanthropy Chairman, Social Chairman, and Parents Day Chairman. He has been involved heavily with his chapter's intramurals and has participated in football, softball, volleyball, basketball, and soccer.

As one of six executive officers of the Interfraternity Conference on the 35,000 student campus of the Pennsylvania State University, Matthew has reason to be proud of his accomplishments. Brother Sarson has been described as, "...truly a leader of fraternity life at Penn State."

In our growing history as a National Fraternity, we have from time to time recognized alumni for notable accomplishments. Until recently, however, recognition had not been awarded in any formal way. Word of outstanding achievements by Fraternity Alumni members was left to an occasional biography printed in the Quill & Scroll, when information was attainable, or a personal appearance before but a few at a National Convention. The National Fraternity has corrected this lack of formal recognition by the founding of Ordo Honorium. The general idea, as intended by the National Board of Directors, is the establishment of a sort of "Hall of Fame" for distinguished alumni.

In 1980, shortly after becoming Executive Director, Donald Stohl, (Zeta '54), set about the inception of Ordo Honorium. Eager to formally recognize the rather impressive achievements of various alumni members, Brother Stohl also saw the opportunity for these outstanding accomplishments to serve as an inspiration to present and future members. Many of the alumni that have been honored by the fraternity have indicated that KDR has made an early and lasting impression on them which helped in their development. An important factor, however, was the notion of "Hall of Fame." While it carries with it the general idea of what the National Board wanted to accomplish, the notion, hackneyed and over-used, has the less desirable connotation of, perhaps, an annual prize for top sales producers. Instead, the Board sought to develop a meaningful basis for the recognition of outstanding alumni.

The obvious path was to follow the tradition of the KDR Ritual and Ceremonies which are based on the model of the ancient Roman Republic. Upon the suggestion of a Benedictine Monk at the Archabbey of St. Vincent College in Western Pennsylvania, the Board finally decided on the distinction Ordo Honorium, "Order of Honor", the honor awarded to Roman citizens for their contribution to state and community.

On August 14, 1982, the initial class of inductees to Ordo Honorium were greeted with the official citation; "Brother, we salute you. Being persuaded of your honor, fidelity and concern for your fellow-man, we have caused these letters to be issued. . ." The initial class of inductees, designated Alpha Class, includes 81 members and recognizes notable accomplishments made during the first 75 years of our Fraternity's history. Each subsequent year, a new class of select inductees, designated by consecutive letters of the Greek alphabet, is chosen.

Selection for membership in Ordo Honorium is rightfully placed in the hands of one's peers. Each year, the individual chapter alumni organizations are asked to submit two nominations for induction into Ordo Honorium. After the nominations are submitted, each nominee is contacted for his acceptance and as these nominations are accepted, the name and biography of each nominee is submitted to the Ordo Selection Committee. This Committee, consisting of current Ordo Honorium members, provides the final selection which is announced at the annual National Convention. Their biographies are published in this issue of the Quill & Scroll. Not all those nominated each year are selected but may be renominated by their chapter in subsequent years. The criteria for selection are based on accomplishment in career, community, and/or optimally, the Fraternity.

Specifically, nominations for Ordo Honorium are made in one of three categories:

1. Personal or professional accomplishments, (including community involvement)
2. National recognition, (sports, entertainment, politics, etc.)
3. Outstanding Fraternity involvement, (Chapter or National)

It is felt that KDRs worthy of the honor and distinction will rise to the top and the selection process will easily recognize their accomplishments. Kappa Delta Rho hopes that all her members will become worthy to join those members currently in Ordo Honorium.



Vice President and General Manager, United Press International For Europe, the Middle East and Africa; Chairman of the Board, Sullivan Marketing, Inc.

Retired — Indiana News Editor and Indianapolis Bureau; Manager, United Press International; Member and corresponding secretary, Epsilon Alumni Corporation

BROTHER GILL, has been nominated and honored this year for his years of devotion to his chapter. This dedication began in 1932, when he pledged our Epsilon Chapter at Franklin College.

Over the years, he has served as secretary and board member of the Alumni Corporation. He was a member of an alumni group who persistently worked to re-establish the chapter, and was responsible for reviving the Epsilon Chapter following World War II. He personally was responsible for raising \$3,000 for capital improvements on the recently purchased chapter house.



Retired United States Army (Turkish Area Specialists); Member and Treasurer, Mu Alumni Corporation


BROTHER MACLEOD attended the University of Michigan, and was a KDR member of Mu Chapter in 1941 and 1942, after which he joined the United States Army.

Founder and Medical Director of the Neumann Eye Institute; Trustee, Gettysburg College

DR. NEUMANN, a member of Pi Chapter, received the Gettysburg College Alumni Association Distinguished Alumni Award in 1986, and was recently named to a six year term on the Gettysburg College Board of Trustees.

Brother Neumann is an internationally known pioneer in the field of Eye surgery, and the Founder and Director of the Neumann Eye Institute in DeLand, Florida. The institute is known for its state-of-the-art surgery, vision research, and educational programs for patients and medical professionals.

In conjunction with the University of Illinois, Dr. Neumann has developed a Radial Keratotomy predictability computer program. This software, designed to assist other ophthalmologists in surgical planning, should be available soon.

In addition to Dr. Neumann's many academic endeavors at several colleges in both Florida and New York, he has many, many publications — (on the order of 150) — such as books, articles, and scientific presentations, to his credit. He also has authored and produced many films, video instruction programs, and audio-digest programs related to Refractive Surgery and other Ophthalmology related subjects. Dr. Neumann's Eye Institute was noted in the Congressional Records of the 98th Congress in 1984, at the request of Senator Paula Hawkins.

Dr. Murphy was selected as a W. K. Kellogg Fellow at the University of Florida in 1969. He is a graduate of Lock Haven University, Temple University and his Ph.D. in Educational Administration was earned at the Catholic University of America in Washington, D.C.

Brother Murphy was a founder of Alpha Alpha Chapter at Lock Haven University and served as its first consul from 1956-59. He was also a founder of the Interfraternity Council at Lock Haven.

DR. HARRY HOOGSTRAAL Eta '38

(Died in Cairo, Egypt, on his 69th birthday, February 24, 1986.)

DR. HARRY HOOGSTRAAL was not only among the most honored Biologists and Medical Entomologists of our time, but was considered the world's foremost authority of ticks and tick-borne diseases. During his 37 years of service as Director of the Medical Zoology Department of Naval Medical Unit Number 3 in Cairo, Egypt, Brother Hoogstraal assembled the world's largest tick specimen and reference library, and was the author of more than 500 publications. He was awarded 23 honorary degrees, medals, special research citations and honorary lectureships. He was the immediate past president of the American Society of Parasitologists and was president-elect of the American Society of Tropical Medicine and Hygiene at the time of his death, having also been honored by both societies with their highest awards for scientific achievement.

His personal success as a research biologist and medical acarologist has yielded more specimens for the Field Museum in Chicago than have come from any other individual collector, as well as significant collections that he has given to other museums.

Dr. Hoogstraal's invaluable research library of some 200,000 items, his extraordinary tick specimen collection (along with the British Museum's, the world's largest), his meticulous field notes, manuscripts, original drawing of ticks, research memorabilia, and other materials will comprise a special Hoogstraal Collection and Tick Study Center that has been established at the Smithsonian Institution as a working, curated collection.

In addition, his Art Library and success as a sculptor are known by many who remain unaware of his reputation as a scientist.

Why A "Trustee and Directors Challenge Fund?"

FIRST, we assume that many Brothers, with successful working experience, value highly the leadership and social experiences of their fraternity years on campus.

SECOND, we assume that our fraternity brothers realize how fragile the fraternity system has been on campuses during recent decades. We observed that the attack on the fraternities was not uniformly applied on all campuses; challenges were more vigorous in some situations relative to others. In order for any Chapter to withstand various types of campus challenges, it is important to create a strong National Fraternity. In numbers there is strength; together we stand, divided we fall. To save one Chapter, we must be ready to save all. A strong National is essential.

THIRD, we assume that potential contributors favor financial support of their local Chapter more than of the National Fraternity. Undergraduates are frequently unaware of any significant service performed on their behalf by the National. This unfortunate image remains unchallenged after graduation.

FOURTH and finally, undergraduate brothers and alumni appreciate the importance of local scholarship funds to rushing efforts. Apart from increasing the lure of our Fraternity, local scholarship funds represent a gift of significant value. According to the Bible, there are only two gifts that one can make; teaching and healing. The funding of scholarship and fraternity activities is a valuable educational gift.

During this fund raising campaign, Trustees and Directors have pledged to match the first \$60,000 of donations, half of which the Trustee and Directors will make available to the Chapter of the donor's choice for scholarship purposes.

This year George Spasyk was recognized for his years of dedication to the fraternity system and his development of the associate member states within Lambda Chi Alpha.

A native of Pittsfield, Massachusetts, George received his Bachelor's and Master's degrees from the University of Michigan in 1949 and 1950 in the field of Labor Economics. After his graduation, he was appointed Traveling Secretary to head up the undergraduate chapter operations of the Fraternity, whose headquarters are located in Indianapolis, Indiana.

A staunch advocate of interfraternity cooperation, George has served as President of the Fraternity Executives Association and he serves on many committees of the Association and of the National Interfraternity Conference. With the conclusion of the 75th annual leadership school and convention, the National Board of Directors recognized and accepted the formation of a new entity within the Fraternity structure. These men are charged with developing National projects, fostering new ideas to improve and cultivate the growth and expansion of our chapters throughout the nation.

The initial meeting of CAB was held on October 31 - November 2, 1986 with Douglas A. Cifu of the Nu Alpha Chapter, (Columbia University), serving as chairman. In the brief descriptions that follow, you will be introduced to some of the outstanding members of Our Fraternity who have, in some way, left such a great mark on their respective chapters, or on the national Fraternity, that their names have been perpetually remembered by the establishment of a scholarship.

The O.D. Roberts Scholarship Fund.



O.D. Roberts

Brother Roberts received his bachelor's degree from the University of Illinois, (Eta '36), and his master's degree from the Northwestern University. As a staunch supporter of Kappa Delta Rho, he served his National Fraternity as Director of Scholarship followed by his election to the National Board of Directors of the National Fraternity in 1956. Also at this time, he was elected National President of KDR and served in this capacity until 1958. Following his presidency, he remained on the Board of Directors until 1962. In 1971, he honored his fraternity by being her first member to serve on the National Interfraternity Conference Board of Directors. Brother Roberts received the Fraternity's highest alumni award in 1981, that of Ordo Honorium. Brother Roberts was a university administrator at Purdue serving as a dean of men emeritus, a professor of education and an assistant vice president. He was listed in Who's Who in American College and University Administrators, Who's Who in America, National Register of Prominent Americans and Directory of International Autobiography.

The O.D. Roberts Scholarship is available to any qualified undergraduate member of Kappa Delta Rho.

The Kenneth C. Kramer Scholarship Fund.



Kenneth Kramer

As a 1954 graduate of the Pennsylvania State University, (Zeta), with a Bachelor of Arts degree in Labor-Management, Brother Kramer came to be known as somewhat of a legend in his chapter. Shortly after receiving his diploma, Dad, (as he was known to his fellow pledge brothers), became actively involved with the Zeta Alumni Corporation as an officer of the Board until his death in 1987. Ken also served his Fraternity as interim Executive Secretary for the National, while serving as a member of the National Board of Directors. During the thirty years of service to his chapter, he shared his life with over 650 young men who passed through the chapter house at 420 East Prospect. Brother Kramer was self-employed as an insurance and investment broker, owning the Kenneth C. Kramer & Associates in State College. He was a member of the Penn State Alumni Association, the Republican Party of Centre County, the Penn State Club of Centre County, the University Club, and was an assistant Scoutmaster of Boy Scout Troupe 31.

The Kenneth C. Kramer Scholarship is available to those qualifying undergraduate members of the Zeta Chapter only.

The Donald Frank Yenko National Scholarship.

Brother Donald F. Yenko, a graduate of the Pennsylvania State University, (Zeta '51), received his degree in Commerce and Finance. Brother Yenko served his Fraternity as Board Member of Zeta Chapter for over 25 years. Both he and his father Frank would come to be greatly respected and admired by the Zeta Chapter. During the early years of his career, Brother Yenko established nine course speed records with his racing team in 1961 and then in 1962 he would break seven of his existing records that were set only one year earlier. Later on he would become affiliated with General Motors in the designing of the Chevrolet Corvair. Brother Yenko also played an instrumental role in the production of the Chevrolet Camaro, Deuce, and Chevelle. As an enthusiastic automobile lover, Donald came to own several car dealerships in the suburbs of Pittsburgh, Pennsylvania.

The Donald Frank Yenko Scholarship is available to any qualified undergraduate member of Kappa Delta Rho.

The Robert D. Lynd Scholarship Fund.

Brother Lynd is a 1967 graduate of Bucknell University, (Iota Chapter), and has been an integral part of Kappa Delta Rho since his early days as an undergraduate. His service to the Fraternity as National Vice President from 1972 until 1974 was a short, yet beneficial experience that would prepare him for the National Presidency that he held from 1974 until 1988. His term as Grand Consul is the longest in the history of Kappa Delta Rho. Although he will serve the Fraternity as Past President for the next two years, he continues to serve Kappa Delta Rho nationally as a member of the National Interfraternity Conference Board of Directors as the executive committees member-at-large. Brother Lynd is a member of the American Bar Association, the Four Star Bar Association, and a member of the Beta class of Ordo Honorium. Currently, Brother Lynd is employed as a Corporate Attorney for Bell Telephone Company in Virginia. Bob received his Judicial Degree from Georgetown University.

The Robert D. Lynd Scholarship was established out of respect for the untiring loyalty and dedication that he has steadfastly given to this Fraternity. The successful undergraduate applicant may be selected from any chapter of Kappa Delta Rho.

The John C. Carl Scholarship Fund.

Brother Carl is a 1951 graduate of Purdue University, (Theta Chapter), and has been a member and officer of the Theta Alumni Corporation for many years. As a dedicated member of Kappa Delta Rho, John was elected to the National Board of Directors in 1987 and currently serves as a trustee to the National Foundation as well as the Director of Finance for that organization. He has been extremely supportive of the Upsilon Alpha Chapter of Kappa Delta Rho at Parks College and serves as Alumnus Advisor for that group. John is President of Southern Illinois Data Corporation, and is an active member in the Knights of Columbus and Kiwanis International. Brother Carl has also served in the United States Navy and was received into the Alpha Class of Ordo Honorium.

The John C. Carl Scholarships are available to those undergraduate members of Kappa Delta Rho who are attending Purdue University, (Theta), and Parks College, (Upsilon Alpha).

The Undergraduate Scholarship Fund.

This innovative scholarship was established as a means to successfully enhance the education of Kappa Delta Rho members. This program is funded by removing \$5 from each initiation fee paid and applying it toward the principal sum of money used to allocate the scholarship. The Clare and Gordon Johnson Charitable Annuity Trust

Brother Gordon Johnson, through his generosity, has established a \$1,000 scholarship that will be provided to one KDR member each year who will enter an accredited graduate law program.

As an enthusiastic member of his fraternity, brother Johnson began his life in the Bay Area of California on August 10, 1905 along with his twin brother Gardiner. Both University of California at Berkeley graduates, (Lambda '26), Gordon and his brother began life by surviving the 1906 earthquake and fire.

Brother Johnson was able to fund his university's tuition by working his way through college at a variety of jobs including a position at the library throughout his time there while still managing to graduate Phi Beta Kappa.

During his career Mr. Johnson distinguished himself as an outstanding labor relations negotiator for the Kaiser and Bechtel Companies during the construction of the Hoover Dam and the San Francisco Bay Bridge. He continued this type of work with the shipyards during the Second World War.

Mr. Johnson soon became a highly successful, and greatly respected, trial attorney as a member of the American College of Trial Lawyers. Soon his attentions were drawn to the area of Anti-Trust, (on behalf of corporate clients), for the remainder of his career, which ended with his passing on May 20, 1985.

Mr. Johnson was married to Clare Chapman in 1938 and she preceded him in death by only a few months in 1985.

that Mae has been a dear member of Sigma Chapter.



Eta House Recognized as Historically Significant



The Eta Chapter of Kappa Delta Rho was established at the University of Illinois campus on February 18, 1921 and has been an interesting, if not vital, force in that community ever since. But, only until recently has the chapter house itself been recognized as being an integral part of the surrounding area.

The Illinois State Historic Preservation Office conducted a survey entitled "The Inventory of Historic Structures for Champaign County" in 1975 and established that six fraternity houses, including KDR, were historically and architecturally significant. With this announcement, the members of the Delta Upsilon Alumni Corporation, whose house was also named, organized the Society for the Preservation of Architecturally Significant Structures and named all six fraternities as members.

Craig Peterson, Assistant Dean of Students at the University of Illinois, is presently trying to establish a program that will recognize more Greek houses for their historical value and structural beauty. By doing this he hopes to be able to acquire tax-ex-

empt status for those structures in need of major renovation and preservation. Unfortunately, due to federal cutbacks in spending, there will not be another historical inventory conducted. However, the Secretary of the Interior has established the National Register of Historic Places so that a property owner who feels that his structure is unique, both in history and architecture, can nominate the building to be placed on the National Register. To date there have been 21 houses in the Champaign County area that have been selected by the Historic Preservation Office.

A Brief History of Eta House

Although not always glamorous, the Kappa Delta Rho house at the University of Illinois campus has had an interesting history. The design for Eta was done entirely by Brother Henning Vagtborg, an architecture major, and a student at the University of Illinois at the time. Following final approval, construction began in 1927 and continued until the first residents would occupy the structure in 1928.

The original style and layout of the house has remained basically unchanged over the years. While upgrades in the heating system have occurred and compliance to local fire and safety codes have been met, major remodeling would occur only in the basement changing the cooks apartment into an entertainment area for the members.

Times were not always good for this house — especially during the 1930s. The depression hit hard with every member trying to save as much money as possible. The early coal heating system would see the brothers going to local mines to haul their own heating fuel, only to find that the sulphur content in the coal was so high that it clogged the air supply and would not burn sufficiently to heat the house.

The membership survived that cold winter only to be subjected to further hardship. Originally, the funding to build the house was provided by the selling of gold bonds in \$100, \$500, and \$1000 denominations to KDR members and other residents of Indiana.

EXPANSION REPORT

OLD DOMINION UNIVERSITY

During the Fall of 1987 several interested students contacted the National Office of Kappa Delta Rho with the hope of becoming affiliated with our organization. Following this initial meeting the group was categorized as a group of intent and their numbers quickly grew to 38 with a pledge class of 16 interested men. The ceremony was held in early September at the Webb Student Union Center on the Old Dominion campus with Brothers Richard Reif, who was originally a student at Radford University, attending as well as Admiral James A. Morgart, (Zeta '59). Brothers who assisted with the installation of the Provisional group were Executive Director of Kappa Delta Rho Donald Stohl, (Zeta '54), and Hunter Miller, (Omega Alpha '89). Hunter was also involved with the cultivation of the original group of intent. Chartering is scheduled for April 15, 1989.

BALL STATE UNIVERSITY

The members of Delta Rho, a local fraternity at Ball State, first made contact with KDR on March 12, 1986 with an interest in forming a national fraternity on their campus. With a group of ten eager men, membership swelled to 40 and the group of intent was inducted as a Provisional Chapter of Kappa Delta Rho on November 15, 1987. With the assistance of Mike Howard, Assistant Executive Director, (Mu Alpha '85), Jim Winters, (Theta '83), Tim Berryman, (Theta '88), and Dr. Gerald Murry, (Theta '66), the installation ceremony was performed at the provisional chapter house. A small celebration took place following the ceremony. On March 31, 1989 this group received their charter.

VIRGINIA TECH UNIVERSITY

Kappa Delta Rho at Virginia Tech began with a contact received by the National Headquarters during the Fall of 1987 when Brother Lee Johnson transferred from the Virginia Commonwealth University. Expressing the desire to establish a chapter on his new campus, Lee took charge and his idea swelled into a group of intent that had total membership of 58. With the help of Dr. Alan Bayer, (Zeta '61), the group was able to meet all requirements established by the National and was



installed as a Provisional Chapter in September of 1988. Several members attending the ceremony held in the Squires Student Union including Dr. Bayer, (Zeta '61), Dr. Pat Mikesell, (Omega '62), Donald Stohl, (Zeta '54), Shawn Davis, (Tau Alpha '88), Evan Wyatt, (Tau Alpha '87), and David Grant, (Tau Alpha '88). April 7, 1989 will be a day to remember as this group receives their charter.

TARLETON STATE UNIVERSITY

Originally brothers of the Sigma Rho local fraternity, these men made the decision to go National during the Fall of 1987. With a roster totalling 20, Kappa Delta Rho established a group of intent on the Tarleton State University. Membership increased to 36 and in March of 1988 the ceremony was held to induct this group as a Provisional

Chapter of our organization. Assisting in the ceremony held at the Tarleton Center was Donald Stohl, (Zeta '54), and William Johnston, (Zeta '63). Also attending were Brothers Matt Quinn, (Theta '85), and Bruce Leonard, (Theta '86). A reception was given for the new initiates by members of Kappa Alpha Fraternity in recognition of the accomplishment of their newest interfraternity brothers. The president of the University is also a member of Kappa Alpha and was in attendance for the celebration. On April 22, 1989 this chapter will receive their charter.

MARY WASHINGTON UNIVERSITY

During the Spring of 1986, students at the Mary Washington University made contact with the National Fraternity of Kappa Delta Rho with the hope of becoming affiliated with a Greek organization. But due to difficulties faced with obtaining proper recognition with the university an actual organization did not occur until the Fall of 1988. During this period membership fluctuated constantly but gradually stabilized at 25 members. Being the first fraternity on the Mary



Washington campus, this group of young men took their first pledge class following the Christmas holidays. The Provisional Chapter ceremony took place in the Student Union Center on Thursday, December 8, 1988 with Virginia Commonwealth University Brothers Brian Aud, Tim Cassel, and Hunter Miller assisting Executive Director Donald Stohl and Leadership Consultant Joseph Bilik with the ritual.

WEST CHESTER UNIVERSITY

During the Fall of 1988 Brother Frank Elliott of Iota Chapter, (Bucknell), made the initial contact with the National Office of the



possibility of establishing a colony of Kappa Delta Rho at the West Chester University. As an original group of 43 enthusiastic men, the ceremony to induct them as pledges of our order was conducted on December 10, 1988 in the Student Union Center. Brother Jeffrey Stevens of Iota Alpha, (University of Pittsburgh at Johnstown) assisted Executive Director Donald Stohl and Leadership Consultant Joseph Bilik with

the ritual. Several area alumni are currently working with this chapter and will be assisting with their growth and development throughout their future.

VIEWPOINT (CONTINUED)

How would this work? Rushees would be initiated following their acceptance of an offer of membership. They would enjoy all rights and privileges as full members with a new method of fraternity education to follow. I have to admit that we do not have all the answers yet, but I will assure you these answers will be forthcoming and will be such that all can accept with confidence and pride.

One last point... in Kappa Delta Rho, we have been extremely successful in expansion because we do not support hazing. All of these new chapters were founded by men who had refused to join other groups because they simply would not risk subjecting themselves to such practices. Brothers, if we can grow to a higher degree without hazing, I feel certain we can continue by supporting the elimination of the pledge status.

Zeta Beta Tau has already announced that they will eliminate the pledge concept from their fraternity in 1989. If we all want to be able to substantiate our existence into the future, we need to listen when our adversaries tell us loud and clear there is no time to wait and see, nor time for second-chance programming. However, it is time for all fraternities to return to values and standards and support the great principles of our heritage.

Times have changed, and we need to accept that the modern young men on our campuses today are not looking for such unofficial and outdated "right of passage" programming. What we need to do is to offer the ability to recruit all the top men and welcome these new members to join us as equals and fraternity brothers, not as second-class citizens. I need to ask seriously — "Isn't that really what fraternity is all about?"

But, with the depression causing interest rates to crash the payments on the bonds were soon in default and the house was nearly foreclosed upon. With the ingenuity of Oscar "Nat" Doud, Otto Gressens, Leslie "Lightfoot" Reid, and Horace "Hot" Gray, an agreement would be reached with the Indiana Insurance Company to procure life insurance on the members of the chapter house that would mature in twenty or thirty years providing for ample payment of the mortgage. The building association would make the premium payments for the members while the certificates were held for collateral.

The war also took its toll on Eta Chapter. Membership fell drastically and the house would reach an occupancy of two as the draft was imposed. Again, the threat of losing this wonderful house was near. The United States Government was training at the University and was in need of housing, so as an attempt to save the building troops were housed there for over two years. Guards were placed at every entrance making it extremely difficult for alumni, or non-resident members, to enter the house without showing sufficient proof of identification.

Following the two years as a barracks, membership at the house was even worse. Occupancy went down to zero and there was a scramble to see that the house would be maintained. For the next year and a half Mrs. Tillman would run a rooming house for all girls. A venture that was to provide some care to the house, but actually proved to be very damaging. The women were less cleanly and hygienic than the army troops and consequently left the house in a state of disrepair.

But, as usual, the Eta Chapter of Kappa Delta Rho prevailed and has been a leader within our Fraternity over the years. With the rich history that Eta has, it is fortunate that her members are so willing to put forth the effort to see that this French Provincial design is rightfully maintained.

Special thanks to Brother Cecil Bernard, (Eta '32), for sharing the chapter's early enlightening memories.



J. HUNTER MILLER




