

STATEMENT OF OPERATIONS

Fellow Brothers:

What follows is a highly condensed Statement of Operations for our National Fraternity for fiscal 1994 ended June 30, 1994. As many of you know, a significant restructuring took place within our National Fraternity during the past twelve months. Staff was reduced, inventories were lowered, and in general if there was a dollar to be cut, it was done. Last year's Convention bit a very bitter bullet and recognized that being the cheapest fraternity in America did not generate the revenue to run our Fraternity. While most fraternities have had undergraduate dues for years, KDR did not. The Convention voted to implement a dues program over four years so that in 1997 our cost to our members will be equal to the average among fraternities. A bitter pill, but necessary. At the same time, the Convention asked for culpability. The new programs detailed in this issue of the Quill and Scroll and indeed the new format to the Quill and Scroll are the first steps toward sound fiscal and programming health. The 1994 Convention just ended was the most upbeat Convention I've had the pleasure to attend. With this air of enthusiasm among our Chapters, I'm looking forward to a great year!

A NEW LOOK FOR THE PATHFINDER

During the Summer, the National Staff took the opportunity to rewrite and update the Pathfinder, our Historical and Educational Manual. Thanks go to brother Adam Fulrath of our Omicron Alpha Chapter at Rutgers for designing the new cover. The content is not materially changed, but is simply updated in the use of language and pictures to provide a more modern source of knowledge about KDR.

NEW CONSUL'S MANUAL INTRODUCED

This Summer the National Fraternity developed a Consul's manual for distribution to the Chapter's this Fall. The new manual is designed to be a "Bible" to which the Consul can turn for suggestions and guidance when confronted with challenges in his position. The manual is a three ring binder format with each section tabbed and labeled for ease of use. For instance, if a chapter lacks motivation, the Consul simply flips to the "motivation" section for programming ideas. The same is true for Rush, Risk Management and virtually every other area of chapter operations. NATIONAL FRATERNITY INDUCTS TWO NEW MEMBERS INTO ORDO HONORIUM

Twelve years ago the National Board of Directors, at the suggestion of a Benedictine Monk at the Archabbey of St. Vincent and with the encouragement of our then Executive Director, Donald L. Stohl (Zeta '54), developed the concept of a fraternal hall of fame. In keeping with the traditions of our ritual and ceremonies, which are based on the ancient roman republic model, our hall of fame was named Ordo Honorium, the honor awarded to Roman citizens for their contributions to state and community.

During that same year the Alpha Class was inducted into Ordo Honorium. This first formal ceremony recognized the accomplishments of 81 members of our order during the first 75 years of our history.

Brother Kowalski grew up in a predominantly polish neighborhood and spoke very little English until the 4th grade. Even after that, brother Kowalski spoke poor English until at the age of 40 he determined that it was important to self improve.

In 1980 brother Kowalski founded Maxi-Blast Inc. with \$34,000 of mostly borrowed money. At one point, he came

within \$315 of closing up shop, then his first order came through. Brother Kowalski's company is now the number one manufacturer of plastic blasting materials in the world. With the growth of his company, brother Kowalski has been repeatedly recognized for his business accomplishments.

In his community, Brother Larsen has participated in the Clergy association; the Rotary Club; the Library Board; the Hospital Board; and served as a volunteer guide for the Old Walled City of Charleston Historical District.

Brother Larsen affiliated with Eta chapter of Kappa Delta Rho at the University of Illinois in 1926. One of his primary roles in the chapter was that of obtaining dates for all the freshmen. LETTER FROM PAUL DOWNES

Since July 1993, I have signed and mailed, on behalf of the Foundation Trustees, over six hundred letters to alumni thanking them for their contributions to the 1993-94 Annual Fund Campaign, which officially ended on June 30, 1994. Each alumnus who made a financial contribution to the Foundation, or who donated their time and talent to the Fraternity or an alumni corporation, are truly an extension of our foundation mission, and I applaud the commitment of each one of them.

The 1993-94 Annual Fund Campaign ended with a total of \$91,605.48 in contributions from 843 alumni.

KDR currently has more than 15,000 alumni. If just 10 percent of our members contributed \$100 to the Annual Fund Campaign, we would be well on our way to restoring fiscal health to the fraternity, and providing additional staff and program support to individual chapters and alumni corporations. Unfortunately, we did not reach that expectation in 1993-94. Undaunted, I am confident that we can achieve and even surpass a goal of \$100,000 for the 1994-95 Annual Fund Campaign, and \$130,000 for 1995-96.

Our 1994-95 campaign is well under way, and the response has been overwhelming. New givers this year outnumber new givers last year by three to one. Many alumni have increased their contributions. Additionally, a few undergraduates and some new alumni have made contributions at a time when their funds may be limited. Whether your contribution is large or small, we are very grateful for the commitment in your gift to the Foundation.

In February, trustees voted to merge the Educational Foundation into the Kappa Delta Rho Foundation on July 1. Both foundations had essentially the same purpose and trustees wanted to avoid duplication of time and effort. With the help of Ray Hunt, the Foundation is constructing systematic audits, setting up procedures to account for all restricted and nonrestricted monies, providing for sound investment of Foundation funds, and making a full financial statement to our members.

This year our National Board of Directors and Foundation Trustees will look carefully at our Fraternity - what kinds of programs and services do we want to offer our undergraduates and alumni, in what kind of formats, and what will the expectations be.

The Foundation extends its appreciation to Cornelius (Neil) Jones, Beta '53, who resigned from the Trustees in early July. Neil brought a sense of urgency and preciseness to our deliberations, and his insight into fund-raising and planned giving was appreciated by all of us. We will miss him greatly, with the hope that his schedule in the future may permit him to rejoin the Foundation Trustees.

I gratefully acknowledge the hard work and guidance of our Trustees Robert Corrie, Beta '53, and Ray Hunt, Jr., Rho '53, who make the policies for the Foundation, and our Investment Committee composed of Robert Corrie; Ray Hunt, Jr.; and Lee H. Idleman, Iota '54.
